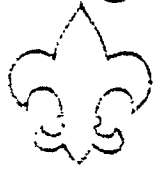

On September 20, 1988 at 12:30 P.M., I talked to Brian Allen, Scout Executive, from Council No. 55. Mr. Allen indicated that he was writing a letter concerning the above named individual, but could not document the facts that we would like for our file.

Mr. Allen indicated that Mr. Keyes was under legal age when the incidents occurred for which he was convicted and put on probation. The files are, therefore, all sealed. He did, however, have some communications with individuals who were aware of this situation and indicated that Mr. Keyes should not be registered with the Boy Scouts of America. We, therefore, will use this as documentation that a permanent file should be established for refusal in the future. If Mr. Keyes desires to get back into Scouting, he would have to prove himself to our satisfaction.
