Please be advised that the undersigned represents the Boy Scouts of America, Inc. as well as the Detroit Area Council of the Boy Scouts of America and Troup 1590 of Madison Heights, Michigan in the above captioned lawsuit which is pending in the Wayne County, Michigan Circuit Court.

Briefly, the case involves allegations of a number of homosexual assaults by a Scout Master of Troup 1590 against the plaintiff, [REDACTED]. The alleged assailant was apparently using an alias when associated with Troup 1590, that being David Johnson. In fact, his given name is David Earl Clark, Social Security Number: [REDACTED] date of birth: August 22, 1940. Unfortunately, it appears that Mr. Clark had a conviction for indecent liberties with a minor which pre-dated the alleged incident involving [REDACTED]. The conviction was in Macomb County, Michigan in 1966 or 1967. That incident involved homosexual assaults perpetrated on [REDACTED], also a Boy Scout affiliated with a Troup out of the Pontiac, Michigan Area Council in approximately 1955. I do not have the exact Troup #, however, Mr. Clark has indicated that it was very likely a Troup in Auburn Heights, Michigan.

The discovery which we have conducted to date in this cause shows that the Boy Scouts National Office maintains a confidential file on all "undesirable" adults that have had contact with the Boy Scouts and whose names become known to the various area councils through complaints made by parents or others. In fact, David Earl Clark has testified that he believes his name was reported to that confidential file or



a "black list" as he referred to it when he was convicted on the indecent liberties charge involving [REDACTED]. He has further indicated that because he was fearful that his name had been reported to the Boy Scouts he created a false identity, David Johnson, and used that identity when becoming involved with the Boy Scouts again with Troup 1590 in Madison Heights, Michigan in the late 1960's.

My purpose in writing you at this time is to inform you that the plaintiff has tentatively scheduled your deposition as well as the depositions of Joseph Early and Paul Ernest for August 9, 1984 commencing at 12:00 noon in your offices in Irving Texas. Your name as well as those of Mr. Early and Mr. Ernest were given to plaintiff's counsel by Joseph Wycoff, recently when his deposition was taken in this case. I am enclosing a copy of the Notice of Depositions for your reference. Please note that the Notice also requires us to produce any and all records concerning David Johnson and/or David Earl Clark, relating to any confidential files which may have been maintained on this individual under either of those names either in connection with Troup 1590 or Madison Heights, Michigan or Troup 159 of Auburn Heights, Michigan in 1964. I must add that we are uncertain as to whether the correct Troup # for the Auburn Heights Troup is actually 159. Mr. Clark was somewhat vague about that in his deposition and it has been more than 20 years since he was affiliated with that Troup. Perhaps you or the appropriate person under your direction could contact me on receipt of this letter to discuss this matter further. I would also appreciate if you would verify your availability as well as that of Mr. Early and Mr. Ernest on August 9, 1984. Thank you for your anticipated cooperation.

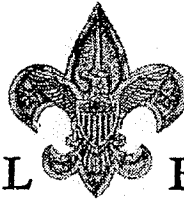

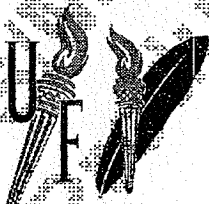

Dear Mr. Boyd:

Attached is the form which you furnished me with your letter of October 22, 1965 regarding our confidential report on Mr. David Earl Clark. To supplement the information on the form, I have these additional items. One of his characteristics is that he speaks very softly. We know of no other distinguishing characteristics or physical marks. We now find that he spent 3 1/2 years in the Air Force (March 1961 to August 1964) and received a General Discharge at Edwards Air Force Base in California, having been charged with perversion while in service. His Serial Number is AF16692454.

This case just came to our attention on October 19 when the State Police here investigated him as a result of complaints from a number of parents in our Troop 141. It was charged that he had molested a number of Scouts. Due to the fact that our District Executive, Mal Warren, was very much on the job immediately, and the fact that we have had excellent cooperation from the State Police, there has been no publicity to date. Several days later, the State Police informed us that several parents had signed formal complaints, and at that time they re-arrested Mr. Clark.

One unusual complication which we particularly direct to your attention is the fact that we have another David E. Clark who is a Scouter in the same small town. Therefore, please note that the Scouter who is still in good standing with us is David Edward Clark, Jr., Assistant Scoutmaster of our Troop 155. He is 35 years of age and ~~apparently~~ no relation to the subject of this report.

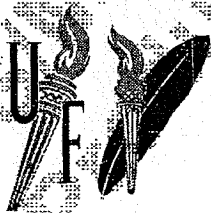
