STATEMENT OF INFORMATION RELATIVE TO DAVID G. DECKER -

On or about February 15, 1989, the Reverend Clyde A. McGee contacted the Great Trail Council regarding concern about Mr. Decker, Scoutmaster of Troop 273, chartered by Rev. McGee's church, St. Stephen's Lutheran Church.

According to Rev. McGee, two former members of Scout Troop 273 confided to him that during their time in the troop, Mr. Decker had fondled them.

Upon interviewing Mr. Decker, he freely admitted his participation in such activities and provided no explanation. He immediately resigned his position as Scoutmaster of the troop and a member of the Boy Scouts of America. Current age of those youth in question is 26, 24, 23, and 21.

We are not aware of any other instances or circumstances regarding Mr. Decker.
