Some of our committee and scouts were present at the trial. We are sure that the prosecuting attorney believed in what he was doing but we were troubled that an accidental brush in an extremely close shower area would cause such hardship for an individual and our troop. Mr. Lesh has had our scouts on many outings. We had a handicapped scout in our troop for a period of time and Mr. Lesh was excellent with him. We have always trusted him and continue to trust him.

Our scouts have personally asked him to return as their scoutmaster but we understand this decision is yours to make. Please do not let our boys down. Let them see that justice does prevail. Our current scoutmaster has agreed to take this job on a temporary basis awaiting David's return to the troop and will be unavailable after July.

As stated in the Scoutmasters Handbook, "It is the committees job to select and recruit the best leaders available and then give those men unending support." We, as a committee and in behalf of our troop, ask you to reinstate David Lesh into scouting.





A PRE TRIAL HEARING WAS HELD 11-16-90 AND THE ASSISTANT PROSECUTOR WANTED ME TO PLEAD GUILTY TO A LESSER CHARGE. I INFORMED MY ATTORNEY I WOULD NOT PLEAD GUILTY AND I WANTED TO CONTINUE WITH 2ND DEGREE C/P. AND GO FOR A JURY TRIAL. TRIAL DATE HAS NOT BEEN SET BUT IS EXPECTED LATE FEBRUARY 1991. WHICH I FIND TO BE UNACCEPTABLE BUT I CAN'T CHANGE THINGS. SO I AM APPLYING TO BSA FOR REINSTATEMENT AS SCOUTMASTER OF SCENIC TRAILS COUNCIL TROOP 4 ALABAMA MICHIGAN.

AFTER HAVING TALKED TO SEVERAL PARENTS WHO HAVE A BOY IN TROOP 4 NO PARENT SAID THAT IF I RETURNED AS SCOUTMASTER THEY WOULD PULL THEIR SONS FROM TROOP 4. I HAVE THE FULL SUPPORT OF TROOP COMMITTEE, PARENTS, MINISTER, FORMER DISTRICT EXECUTIVE, DISTRICT CHAIRMAN AND FRIENDS OF SCOUTING AND THEY WOULD LIKE TO SEE ME BACK AS SCOUTMASTER.

I CAN ASSURE YOU THAT THE BOYS ARE AS SAFE WITH ME NOW AS THEY HAVE ALWAYS HAVE BEEN.

I'VE DECIDED I AM NOT GOING TO WAIT TILL AFTER THE TRIAL TO REAPPLY FOR MEMBERSHIP INTO THE BSA. I WANT TO BE REINSTATED NOW AS I HAVE NOT DONE ANYTHING WRONG AND I AM NOT GOING TO LET 2 BOYS

IN TROOP 27 CHEAT THE BOYS OF TROOP 4 THE ASSISTANT SCOUTMASTERS AND MYSELF OUT OF HAVING A GOOD TIME SCOUTING.

I THINK ABOUT ALL THE GOOD TIMES WE HAVE HAD CAMPING, HIKING AND EXPLORING AND THE FELLOWSHIP WE HAVE HAD AROUND THE EVENING CAMPFIRES AND THE OPPORTUNITY TO LISTEN AND SHARE STORIES. AND LISTEN TO SCOUTS AND SCOUTERS RE-LIVE THE GREAT TIMES WE HAVE HAD. ALSO IT'S A GREAT TIME TO FIND OUT WHAT TYPE OF ACTIVITIES THE SCOUTS WOULD LIKE TO PLAN NEXT.

I MADE ARRANGEMENTS FOR THE ACTING SCOUTMASTER TO TAKE THE SCOUTS TO CENTRAL MICHIGAN UNIVERSITY TO A FOOTBALL GAME. SOME SCOUTS HAD NEVER BEEN TO A COLLEGE FOOTBALL GAME. THE SCOUTS AND SCOUTERS HAD A GOOD TIME. I WISH I COULD HAVE BEEN THERE TO SHARE IT WITH THEM. THE FIRST PART OF DECEMBER THERE SHOULD BE A CAMPOUT AND THE LAST WEEKEND THE LAST MEETING BEFORE CHRISTMAS WE HAD A ~~CONTEST~~ / ~~MEETING~~ / ~~EVENT~~, I WANT TO BE THERE. I ALSO WANT TO TAKE OUR MEMBERS AND INVITE TO THE WINTER EXTRAVAGANZA WEEKEND. I'VE BEEN THERE AND IT IS ALWAYS A LOT OF FUN.

I HAVE MADE PLANS TO TAKE TROOP 4 TO LAKE SUPERIOR STATE TO A HOCKEY GAME FEB. 2, 1991 SOME SCOUTS HAVE NEVER BEEN TO A COLLEGE HOCKEY GAME. I AM ALSO LOOKING FORWARD TO TAKING THE SCOUTS TO THE KLONDIKE DERBY AND SPENDING THE NIGHT SLEEPING IN A SNOWBAKE.

WE HAVE ALWAYS TRIED TO HAVE A CAMPOUT ONCE A MONTH. AND IN THE LAST 4 MONTHS THE SCOUTS HAVE HAD ONLY 2 CAMPOUTS. THERE JUST IS NOT ENOUGH ADULTS WHO WILL GO AHEAD AND MAKE THINGS HAPPEN.

IN JULY 1990 WE HAD 3 ASSISTANT SCOUTMASTERS.
ONE IS NOW ACTING SCOUTMASTER. ANOTHER ASSISTANT
SCOUTMASTER AND EAGLE SCOUT PROBABLY WILL LEAVE SCOUTING
IF I DON'T RETURN. HE HAS NOT ATTENDED ANY MEETINGS
SINCE I WAS ASK TO LEAVE SCOUTING. THE OTHER ASSISTANT
SCOUTMASTER IS PLANNING ON LEAVING DUE TO LACK OF
COOPERATION FROM ACTING SCOUTMASTER. THE ACTING
SCOUTMASTER DOES NOT WANT TO BECOME SCOUTMASTER
HE IS ROUND TABLE CHAIRMAN AND WOULD LIKE TO
SEE ME BACK AS SCOUTMASTER.

AS I GO BACK AND READ THIS LETTER IT WOULD BE A LOT
EASIER FACE TO FACE THEN FOR ME TO PUT THIS IN
WRITING AS I BELIEVE IN SCOUTING AND I WANT TO BE A
PART OF IT. BUT THIS LETTER IS THE BEST I CAN DO
FOR NOW.

ENCLOSED WITH THIS LETTER IS AN APPLICATION FOR
MEMBERSHIP INTO THE BSA. I DON'T MEAN TO PUT
PRESSURE ON YOU BUT I WANT TO BE REINSTATED
AS A MEMBER OF BSA. NOW AND NOT SOME TIME NEXT
SPRING. SO THE DECISION IS UP TO YOU, MAY I JOIN
THE WINNING SCOUTING TEAM OF TROOP 4 AGAIN.

IF THIS APPLICATION IS NOT APPROVED I WILL INFORM
THE TROOP COMMITTEE THEY HAD BETTER START LOOKING
FOR A NEW SCOUTMASTER. AS MY REQUEST IN NOV. 1990
HAS BEEN DENIED. I WILL ACCEPT YOUR DECISION AS
NAL AND WILL NOT REAPPLY AGAIN.

A PERSONAL NOTE:

11-19-90

I AM CHARGED WITH 2ND DEGREE CRIMINAL CONDUCT. I AM ACCUSED OF TOUCHING A 17 YEAR OLD BOY ON THE BUTTOCK. I MAY HAVE BUMPED HIM BUT I WOULD NEVER REACH OUT AND TOUCH A BOYS BUTTOCK FOR WHATEVER REASON. BUT I CAN ACCEPT THE FACT I MAY HAVE ACCIDENTALLY BUMPED HIM. AND IF HIS FRIENDS HAD NOT BEEN PLAYING WITH THE WATER VALVES I WOULD NOT HAVE TO STEP AWAY FROM MY SHOWER HEAD, AND I'M NOT SO SURE HE DID NOT STEP AWAY TO AND WE JUST GOT TO CLOSE TOGETHER AND MY ARM/HAND MAY HAVE ACCIDENTALLY TOUCHED THE BOY. AS THE BOYS WERE TURNING THE HOT/COLD WATER VALVE ON/OFF SEVERAL TIMES MAKING THE REMAINING SHOWER HEADS TURN HOT/COLD.

AS I LOOK AT THIS IT IS AN UNFORTUNATE ACCIDENT AND IT COULD HAVE BEEN HANDLED IN A BETTER MANNER. HOWEVER, WHAT IS DONE IS DONE AND WE HAVE TO LIVE WITH IT. I WOULD LIKE TO APOLOGIZE TO THE BOY BUT THE JUDGE AT THE APPOINTMENT SAID I WAS NOT TO HAVE ANY CONTACT WITH THE BOY. BUT IT WOULD BE NICE TO SAY I'M SORRY IF I BUMPED INTO YOU AND THAT IT WAS NOT INTENTIONAL AND I CERTAINLY WOULD NOT TOUCH SOMEONE WITH OTHERS IN THE SHOWER AT THE SAME TIME. SO SOME DAY I MAY GET THE OPPORTUNITY TELL THE BOY I'M SORRY IF I ACCIDENTALLY BUMPED INTO YOU.

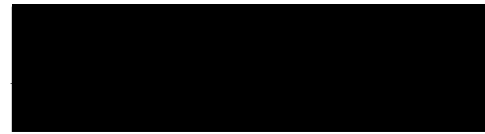

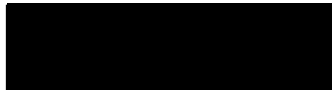

As follows: Interview with leader: As reported to Robert McManus - subject in shower with Scouts - moved in with boys when opportunity presented itself - after "joining Scouts" subject patted [REDACTED] on buttocks - [REDACTED] witnessed incident. Three other Scouts acknowledged movement of leader to side with boys, but did not witness the "touching".

Interview with Scouts: Came in after Scouts entered - followed boys all week - Wednesday and Monday night also followed Scouts around camp during the week. Deliberate touching - not accident, according to victim and witness. Identification of subject was made by telling what subject was wearing at Friday morning flag ceremony (yellow, "Do It Now, Nike) shirt.

CHRONOLOGY OF FOLLOW UP TO REPORTED INCIDENT

Friday, July 20, 1990

10:00 a.m. Camp Operations Director contacted Scout Executive, Paul J. Ryan and reported that two Scouts of Troop 27 had a possible molestation performed by a Scoutmaster (of another troop) at 10:30 p.m. the previous evening.

10:45 a.m. Scout Executive reported alleged incident to Al Morin, Area (State) Director of the Boy Scouts of America.

10:50 a.m. Scout Executive telephoned Department of Social Services and reported alleged incident - representative of Department of Social Services stated that an officer would contact the Scout Executive between 1:00 and 3:00 p.m. this day.

11:00 a.m. Scout Executive contacted executive board member and retired State Police Captain, John K. Cosgrove, Boy Scout executive board member in charge of such matters and reported incident to him.

12:00 noon Scout Executive went to council office and retrieved membership records on both Scout troops involved.

12:15 p.m. Scout Executive made a confidential call to former district executive, Brian Granger, a troop committeeman of the alleged offender's troop, for the purpose of checking out the alleged offender's background. Mr. Granger reported that there had been no previous incidents in the accused background.

Scout Executive proceeded to camp.

1:15 p.m. Department of Social Service's agent telephone Scout executive at camp. The Department of Social Service's agent stated that, since the Scout executive intended to ask the alleged offender to leave camp, the Department of Social Services would not be involved in any child protection and to report the incident to the law enforcement agency with jurisdiction.

1:25 p.m. Scout Executive contacted Michigan State Police, more specifically, Trooper Ray Burke. Trooper Burke directed the Scout executive to keep the alleged victims and the alleged offender in camp until he could come to camp at 4:00 p.m.

2:30 p.m. Scout Executive met with two Scouts and requested that they come back at 4:00 p.m. to visit with Trooper Burke.

2:45 p.m. Scout Executive met with accused Scoutmaster and asked him to meet with Trooper Burke at 4:30 p.m.

3:15 p.m. Scout Executive attempted to telephone both alleged victims' parents. Scout Executive got in telephone contact with one and informed her that the Trooper would be meeting with her boys at 4:00 p.m. She stated that she would contact the other parent and inform her of that fact.

4:15 p.m. State Trooper Ray Burke interviewed the alleged victim and the witness.

(continued)

4:45 p.m. Trooper Burke interviewed the alleged offender.

5:00 p.m. Scout Executive met with the alleged offender and requested that he leave camp.

5:15 p.m. Scout Executive informed Camp Director that alleged offender was leaving camp.

5:30 p.m. Scout Executive followed alleged offender out of camp until he reached the highway six miles away.

Approximately
8:00 p.m. Parents of alleged victim visited camp on regular parents' night. They thanked their own Scoutmaster for the way the Boy Scouts handled the situation. The Scoutmaster reported their cooperative attitude to the Camp Director.

July 21 Scout Executive contacted Area Director and reported results.

July 21 Scout Executive wrote refund check, of registration fee, to offender.

July 22 Scout Executive notified Joseph J. Muha, Council President.

July 23 Scout Executive wrote registered letter revoking registration in the Boy Scouts of America to alleged offender and enclosed a check for \$7 registration refund.

July 24 Scout Executive contacted the National Council, Boy Scouts of America, and reported the incident to the director of registration.

July 29 Attempted to contact Methodist Church, Alanson, and found Pastor not in area for extended period.

July 29 Informed Brian Granger, Troop 4 Committeeman and former District Executive, to advise that accused should not have contact with Scouts.

August 2 Accused contacted Roger Clark, Troop 4 Assistant Scoutmaster and District Committee Member, that he would not be active in troop.

August 2 Mr. Clark contacted Scout Executive, by phone, and asked why accused had removed himself from troop. Scout Executive confidentially informed Mr. Clark that accused could no longer participate and requested Mr. Clark to conduct future troop functions, at least on temporary basis.

August 6 Scout council sent badge order, originally ordered by accused, to Mr. Clark for distribution.

(continued)

August 7 Ed Brochu, District Chairman and accused's employer, contacted Scout Executive and asked why accused had "resigned". Scout Executive briefed District Chairman. District Chairman stated that he would maintain confidentiality and the accused would not have his employment in jeopardy.

August 7 Scout Executive mailed this accounting, copy of letter to accused, copy of postal restricted delivery acceptance card signed by accused, and National Ineligible Volunteer Record Sheet to: Area Director; National Registration Service; William Wise, Council Vice President/Law.

The results of this incident are in the hands of the Michigan State Police investigation unit.

Important: Please be advised that the alleged victims nor their parents know the name and address of the accused and the accused does not know the names or address of the victims - it would be wise to maintain this confidentiality at present.

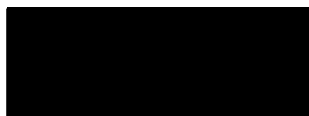

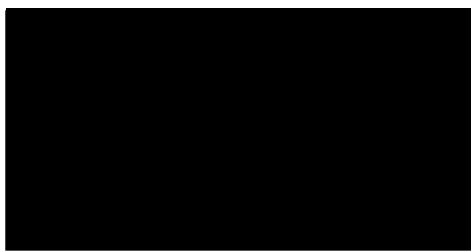

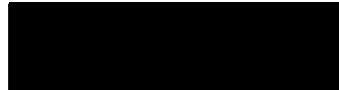

As follows: Interview with leader: As reported to Robert McManus - subject in shower with Scouts - moved in with boys when opportunity presented itself - after "joining Scouts" subject patted [REDACTED] on buttocks - [REDACTED] witnessed incident. Three other Scouts acknowledged movement of leader to side with boys, but did not witness the "touching".

Interview with Scouts: Came in after Scouts entered - followed boys all week - Wednesday and Monday night also followed Scouts around camp during the week. Deliberate touching - not accident, according to victim and witness. Identification of subject was made by telling what subject was wearing at Friday morning flag ceremony (yellow, "Do It Now, Nike) shirt.

CHRONOLOGY OF FOLLOW UP TO REPORTED INCIDENT

Friday, July 20, 1990

10:00 a.m. Camp Operations Director contacted Scout Executive, Paul J. Ryan and reported that two Scouts of Troop 27 had a possible molestation performed by a Scoutmaster (of another troop) at 10:30 p.m. the previous evening.

10:45 a.m. Scout Executive reported alleged incident to Al Morin, Area (State) Director of the Boy Scouts of America.

10:50 a.m. Scout Executive telephoned Department of Social Services and reported alleged incident - representative of Department of Social Services stated that an officer would contact the Scout Executive between 1:00 and 3:00 p.m. this day.

11:00 a.m. Scout Executive contacted executive board member and retired State Police Captain, John K. Cosgrove, Boy Scout executive board member in charge of such matters and reported incident to him.

12:00 noon Scout Executive went to council office and retrieved membership records on both Scout troops involved.

12:15 p.m. Scout Executive made a confidential call to former district executive, Brian Granger, a troop committeeman of the alleged offender's troop, for the purpose of checking out the alleged offender's background. Mr. Granger reported that there had been no previous incidents in the accused background.

Scout Executive proceeded to camp.

1:15 p.m. Department of Social Service's agent telephone Scout executive at camp. The Department of Social Service's agent stated that, since the Scout executive intended to ask the alleged offender to leave camp, the Department of Social Services would not be involved in any child protection and to report the incident to the law enforcement agency with jurisdiction.

1:25 p.m. Scout Executive contacted Michigan State Police, more specifically, Trooper Ray Burke. Trooper Burke directed the Scout executive to keep the alleged victims and the alleged offender in camp until he could come to camp at 4:00 p.m.

2:30 p.m. Scout Executive met with two Scouts and requested that they come back at 4:00 p.m. to visit with Trooper Burke.

2:45 p.m. Scout Executive met with accused Scoutmaster and asked him to meet with Trooper Burke at 4:30 p.m.

3:15 p.m. Scout Executive attempted to telephone both alleged victims' parents. Scout Executive got in telephone contact with one and informed her that the Trooper would be meeting with her boys at 4:00 p.m. She stated that she would contact the other parent and inform her of that fact.

4:15 p.m. State Trooper Ray Burke interviewed the alleged victim and the witness.

4:45 p.m. Trooper Burke interviewed the alleged offender.

5:00 p.m. Scout Executive met with the alleged offender and requested that he leave camp.

5:15 p.m. Scout Executive informed Camp Director that alleged offender was leaving camp.

5:30 p.m. Scout Executive followed alleged offender out of camp until he reached the highway six miles away.

Approximately
8:00 p.m. Parents of alleged victim visited camp on regular parents' night. They thanked their own Scoutmaster for the way the Boy Scouts handled the situation. The Scoutmaster reported their cooperative attitude to the Camp Director.

July 21 Scout Executive contacted Area Director and reported results.

July 21 Scout Executive wrote refund check, of registration fee, to offender.

July 22 Scout Executive notified Joseph J. Muha, Council President.

July 23 Scout Executive wrote registered letter revoking registration in the Boy Scouts of America to alleged offender and enclosed a check for \$7 registration refund.

July 24 Scout Executive contacted the National Council, Boy Scouts of America, and reported the incident to the director of registration.

July 29 Attempted to contact Methodist Church, Alanson, and found Pastor not in area for extended period.

July 29 Informed Brian Granger, Troop 4 Committeeman and former District Executive, to advise that accused should not have contact with Scouts.

August 2 Accused contacted Roger Clark, Troop 4 Assistant Scoutmaster and District Committee Member, that he would not be active in troop.

August 2 Mr. Clark contacted Scout Executive, by phone, and asked why accused had removed himself from troop. Scout Executive confidentially informed Mr. Clark that accused could no longer participate and requested Mr. Clark to conduct future troop functions, at least on temporary basis.

August 6 Scout council sent badge order, originally ordered by accused, to Mr. Clark for distribution.

August 7 Ed Brochu, District Chairman and accused's employer, contacted Scout Executive and asked why accused had "resigned". Scout Executive briefed District Chairman. District Chairman stated that he would maintain confidentiality and the accused would not have his employment in jeopardy.

August 7 Scout Executive mailed this accounting, copy of letter to accused, copy of postal restricted delivery acceptance card signed by accused, and National Ineligible Volunteer Record Sheet to: Area Director; National Registration Service; William Wise, Council Vice President/Law.

The results of this incident are in the hands of the Michigan State Police investigation unit.

Important: Please be advised that the alleged victims nor their parents know the name and address of the accused and the accused does not know the names or address of the victims - it would be wise to maintain this confidentiality at present.


