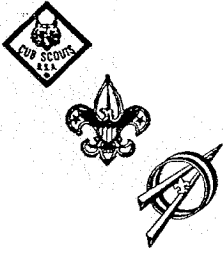

It is with regret that I must submit the name of David H. Dailey to be listed in your confidential files.

Mr. Dailey is currently registered as a Neighborhood Commissioner, RFD #4, New Milford, Conn., 06776. He is an American citizen, 21 years of age and is multi-registered as committeeman for Troop 26.

Mr. Dailey was picked up by the local police recently on a morals charge and was sentenced last week to either 2 years in a reformatory or to be submitted to the state mental institution. He has chosen the latter course. Due to the seriousness of his crime, he was lucky to get off with this light sentence because had he been brought before a Bridgeport, Conn. judge who had tried him on a similar charge two years ago, he would have gotten a much more severe punishment. We were unaware of his previous charge, however we were informed that he had been seeing a psychiatrist but was under control of himself and there was no reason why he should not carry on a normal life. I would like to add that as far as we know, all of Mr. Dailey's activities were outside of Scouting circles and therefore brought no disgrace to the Boy Scouts, other than his being currently registered.

Enclosed you will find photostatic copies of recent letters he has sent me.

Thank you very much for your kind letter dated October 7, 1968. I do appreciate it very much. I also appreciate your concern with this situation, but I'm afraid that this situation is a bit more serious than what you may have thought. It concerns an arrest of September 24, 1968. The arrest was for a serious moral count plus a count for risk of injury to a minor. If this does satisfy your appreciated curiosity, I have the article in the paper which I could send you upon request.

I deeply thank you for your wish to sit down and talk this over, but now that you know the situation a bit more clearly, do you still wish to do this? I am receiving psychiatric help, not that I need it, but there might have been a mental block or something like that, during the act. I don't know.

However, I do sincerely appreciate your concern and I hope that everything will turn out ok.

Due to this, I felt obligated to drop out of Scouting.
