MANY PEOPLE REFUSE TO BELIEVE THE WORST ABOUT DAVID TURMENNE, EVEN SOME PARENTS HAVE BEEN TOLD BUT REFUSE TO LISTEN. WE HAVE A DUTY TO PROTECT THESE YOUNG BOYS, IF YOU SEE DAVID TURMENNE WITH YOUNG MALES OR HAVE ANY INFORMATION OLD OR NEW REGARDING PERSONAL ENCOUNTERS WITH THIS VERY SICK PERSON YOU ARE URGED TO CONTACT OFFICER BROWN OF THE LEWISTON POLICE DEPT. JUVINILE DIVISION.

AS GOD IS OUR WHITNESS WE SWEAR THIS INFORMATION IS TRUE IF YOU CAN HELP PLEASE CALL THE POLICE TODAY DON'T LET ANOTHER BOY BE IN HARMS WAY.

YOU HAVE RECIEVED THIS BECAUSE YOU MAY HAVE INFO/KNOLEDGE THAT CAN STOP THIS SORT OF THING FROM REPEATING ITSELF, YOU MAY BE THE ONLY HOPE THE NEXT VICTIM HAS BETWEEN A NORMAL LIFE AND A LIFE LIKE THE TORTURED ONE DAVID J. TURMENNE IS NOW LEADING.
