

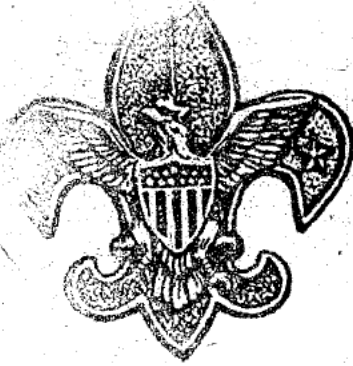

Statement by [REDACTED] 10:15 am

I went to bed at 1:00 am; I was awakened at about 1:30 by Dave (Henne). He gave me a Vitamin B tablet, which he claimed would keep mosquitoes off because of its smell. It smelled okay but it burned all the way down; I gasped for air for about five minutes -- I couldn't breathe. Then he gave me some foot-beer to wash it down.

I was awakened at about 3:00 and I found that he was in my bed, rubbing my body. I told him that I was going to throw up, then he left.

(When asked which parts of his body were rubbed, [REDACTED] answered -- from the waist to the chin area, and about 6-9 inches below the waist).

I got up and faked I was throwing up in back of the cabin. I then went back to bed and was awakened at about 5:00. (I have a clock under my pillow) He was rubbing me near my private areas. I kept my hand covering my penis. The sleeping bag was wet and I was pushed up against the wall. I told him to leave and he left.

Dear Howard,


Last summer we had reason to ask the man named above to leave our camp Rotary where he was serving as a scoutmaster with a scout troop from Saginaw. We asked this man to leave the camp because of a suspected homosexual approach which it was claimed he made to one of our young camp staff members.

Our personnel have been investigating this matter and just recently this man, David Henne was arrested by United States authorities on a charge of extortion in that he used the United States mails to extort money from a young man using the information which he claimed to have regarding this young mans violation of the accepted moral code.

When the case was brought to court, the attorneys for Mr. Henne pled Nolo Contendere. This case is now being considered by the court and although we have had no report as to the final judgement in this case, we feel that there is enough information here to make it imperative that we request this man be put on the confidential file in order that he will have no further opportunity to associate himself with the Boy Scouting program in a registered capacity.

If you need further information regarding this matter, we will be glad to secure it. Otherwise, we would appreciate your placing this mans name on our confidential list.
