Dear Rog:

After receiving the termination letter from the council office I called on George Boyett to witness the presentation of the letter. Upon returning Friday evening I picked up George and we traveled to David Dixons' home in Bryan arriving at approximately 6:30p.m. David Dickens was not at home and did not return Friday evening at a reasonable hour.

George and I saw him arrive at the Webelos Do-Your-Best at Camp Arrowmoon at about 9:00a.m., April 9. We approached his vehicle, exchanged greetings, saw that he had boys in the van and elected not to approach him at that time, but allow him to off-load and return.

During this time we took the opportunity to present copies of the letter to David Cantey, WL of Pack 371, and their Scouting Coordinator, Bruce Slack. We answered some of their questions and explained the review process. David Dickens returned from the campsite in his van.

George and I noted that there were two Webelos in the vehicle and assisted in removing them from the scene. Upon clearing the area we presented David Dickens with the letter.

He was visibly shaken, yet remained calm, as I explained the situation. He asked a number of questions and I referred him to you. He also commented that he thought he had answered all questions concerning his character ten years ago at a hearing.

Those present at the time the letter was presented to David Dickens were myself, George Boyett, Bruce Slack, David Cantey, and Harold Wilson who diverted those that approached. Great care was taken to minimize embarrassment.

THE PURPOSE OF THIS MEETING WAS TO INFORM ALTON NEATHERLIN OF THE STATUS OF SHIP 5004 SPONSORED BY THE HIGHLANDS STAR NEWS-PAPER. HE WAS INFORMED THAT THE UNIT WAS REGISTERED AND FUNCT-IONING IN SPITE OF SOME NEGATIVE FEELINGS FROM SOME HIGHLANDS CITIZENS ABOUT THE SKIPPER, DAVID DICKENS. ALTON SAID HE STILL FEELS THE B.S.A. SHOULD BE ABLE TO REJECT A UNIT APPLICATION IF "WE" FEEL THE LEADER IS UNSUITABLE. HE WAS INFORMED AGAIN THAT THAT RESPONSIBILITY WAS HIS AS HEAD OF THE SPONSORING INSTITUTION. HE WAS IN THE PAST GIVEN THE OPPORTUNITY TO STOP THE CHARTER AND AS I.R. HE CHOSE NOT TO DO SO FOR PERSONAL REASONS. BILL MINTO EMPHASIZED THE B.S.A.'S POSITION IN NOT BEING ABLE TO REJECT A PERSON ON "HEAR-SAY" EVIDENCE. SAID HE UNDERSTOOD OUR POSITION. ALTON ALSO SAID HE WAS ENC-OURAGED BY SEEING THE OTHER ADULTS WHO WILL BE WORKING WITH DAVE DICKENS, AS THEY SEEM TO BE FINE, QUALIFIED INDIVIDUALS. IT WAS ALSO MENTIONED THAT DAVID DICKENS POSSIBLY OWED SOME OF THE COMPLAINTANTS MONEY AND IN ALTON'S WORDS" THIS MIGHT BE THE ROOT OF THIS WHOLE THING." THE MEETING ENDED WITH ALTON NEATHERLIN BELIEVING THE UNIT SHOULD NOT HAVE BEEN CHARTERED BUT SATISFIED THAT THE B.S.A. DID THE ONLY THING "WE" COULD DO IN THIS SITUATION AND OPTIMISTIC THAT THE UNIT WILL SUCCEED AND FUNCTION PROPERLY IN THE FUTURE.

REPORT OF JOHNNY W. ATKINS

INTERVIEW WITH

I am Johnny Atkins, Scout Executive of Three Rivers Council, Boy Scouts of America and I have with her Herb Spangler, our Program Director. Your name is ...That's right, it is. ATKINS...Okay, you're aware that we are recording this conversation? ... Yes I am. ATKINS...Okay. I have a letter from Bill Clark who is Director of Field Service of the Sam Houston Area Council, Boy Scouts of America in Houston that you wrote him on May 17. Is this the letter you wrote? ...Yes, it is. ATKINS... how long have you ...Since known Dave Dickens? ATKINS...Okay, In the letter, you made some rather serious accusations related to Mr. Dickens. Do you stand behind these accusations? ... I most certainly do. ATKINS...Is there anything you can add to them or explain former on the accusa-... Well, Mr. Dickens has been frauding the Veterans tions that you had made? Administration, too for money for which he wasn't suppose to get and he has had prostitutes come to his home, not just child prostitutes but prostitutes come to his home for solicitation. I have been there when it has happened and I can tell you that everything else I have written in that letter is absolutely true and I will stand by every word I've said. Mr. Dickens has solicited young couples to join his Sea Scout Troop in order that he may make it with the wife. ATKINS... Has this taken place in Houston or where? ... In Baytown where I live. It happened at my house, it was one of my friends. ATKINS...Could you give me the friend's name please? Well, I just remember that their first names were . He has got the papers where he has signed them up and he came over to my house and a lasagna dinner and he told me himself that he was going to get them to join the group because he wanted to go to bed with . I am very scared for the young girls in the troop



because he's not mentally sound. He got a mental discharge from the service because he shot and killed a young guard on purpose. He shot and killed him and he got a mental discharge and is under mental health care from a psychiatrist named Dr. Denton at the V.A. right now. He goes on in tangents where he thinks Dracula is trying to get him or that he sees God and things like that and a person with this type of mind it just disturbs me that they are allow to lead a young group of boys and girls. I just don't see that he is a fit person. ATKINS...Okay, thank you very much. Is there commond-law with a woman he calls his . She is also a member of the troop. that he has got and I just don't know about her stability either, because I've spoke to her about what I've told you and she knows about his mental disabilities and the tangents that he goes on. And she doesn't seem to care one way or the other, so I have done all I can to try and help him but he is beyond help and he is just not a fit person. I wouldn't want my children there in his troop. ATKINS...Okay, thank you. Also here with us and is ...Mr. Dickens has provoked that he would like to make a statement also. some violence at my house in Baytown. Preceded to jump on me and a young man that was staying with me jumped in the way and wound up getting hurt and had to go to the hospital and I wound up going to jail. Mr. Dickens is a little bit of a violent nature. One of the prostitutes that I knew in Houston came over to his house, her name is I can't think of her last name right off. If I could get in touch with him she will testify because I have already talked with her. And so will he is from Houston. He would testify to the violence Mr. Dickens had come over to my house and earlier that day had tried to run over me with his truck. ATKINS...Okay, thank you. Did you have something to add ...I sure do. her father is and they young child prostitute is named in Nortshore, Texas. 70015 is their zip and their phone number ATKINS...Okay, thank you. ...I had a girl who stayed at my


a lot that was 7 months pregnant. Her name is and she solicited at my house when I was gone and I found out about it and I asked my wife about it and she told me very frankly about the situation and I asked David about it and he admitted ... The very first night that we moved in over there my husband wasn't was. Her first name is but her nickname is and with me, but he solicited her that night when he sent me to the grocery store to get some groceries. And he had done it several times before. I asked him not to but he just didn't seem to think that it matter any. So I mean, like I said I don't think he is a fit person and I will go to any length to make sure he doesn't have a Scout Troop because I don't think the children should be subjected to things like that. ATKINS...Okay, the lady who just walked in _____ is your mother. ____.That's right. ATKINS...Okay, would you like to make a statement related to Dave's work in the Boy Scouts of America? ..All I know is that he has worked for several years in the Boy Scouts with the Boy Scouts and he has gotten all kinds of merit awards but he has retired now from the Boy Scouts. ATKINS...He has retired now from the Boy Scouts. he still has Sea Scout ..Yes, he has retired. ...No ... No, he told me the other day that he retired. Troop. ..He lied to you. ..All I know is what the boy told me that he had retired from the Boy Scouts. ... He has a troop in Highlands. In fact, his troop building is right next door to a beer joint called the Shaker in Highlands.

And they have regular meetings I believe on Thursday nights down there in Highlands.

ATKINS...Okay, we would like to thank y'all for your interest and this recording will

be mailed to Houston and they are the ones conducting the investigation and the allo-

cations that you had made. Okay? ... Okay, thank you. ATKINS... Thank you.



REPORT OF: DISCUSSION BETWEEN BILL CLARK, DIRECTOR OF FIELD SERVICE AND CARLOS
DEL HIERRO, FIELD DIRECTOR RELATED TO THE INITIAL SPONSORSHIP OF
SEA EXPLORER POST 5004 OF WHICH DAVE DICKENS IS THE SKIPPER

I was contacted by Dave Dickens sometime in April or May of 1978. He wanted to organize a Sea Explorer Ship.

He stated he was working on a sponsor. At this time, I spoke with Bob Harper about helping Dave get started.

A few weeks later Dave informed me that the Highland Star would serve as the Ship's sponsor.

Dave, on his own, began to contact civic clubs in Highlands for financial support. It was at this point that his "character" became questionable to me.

I received a call from a Baptist Minister in Highlands. The minister told me that one of his congregation had spoken to him about Dave Dickens. According to the "mother", Dave made improper remarks about a young daughter.

Bob Harper and I met in Highlands with the Baptist Minister, "mother", Pappy Marlen and the owner of the Highland Star.

All present were critial of Dave's personal character and wanted the Boy Scouts of America to act. At this point I explained that we would need written documentation - none was ever obtained.

The major point that came from this meeting was that Dave was living with a woman. Dave said it was his aunt. The community felt otherwise.

After this meeting, on the same day, Bob and I spoke with the local drugest. He implied Dave was of bad moral character - he inferred that Dave was mentally ill because of the medication he was taking. He was also very critical of Dave living with a woman.

At a later time (maybe 10 days), Bob Harper and I spoke with the owner of the Highland Star and re-explained the situation. Also explained that he could, if he so desired, not approve Dave as the Advisor. The editor did not want to hurt the feelings of the "woman" Dave was living with. The woman is the widow of a man who was respected by the town and was a good friend of the editor. Bill Minto was present at this meeting.

As a final result, the Ship was chartered in May - the Ship has never grown a number.

I did hear from Walter Tippitt, Skipper of Ship 616, that Dave had been fined or trespassing on private property.

I asked that Bob Harper write a critique of all we had done to solve the prolem. A copy of this was shared with Bill Clark. Silver Rivers Boyscont Concil



and she has a statement to make in connection with Interviewing David Dickson and her association with David Dickson. And this I know him as Dave Dickens. The first time I met Dave Dickens was at the Scout Show in the first week of December of 1978. He was with a Sea Scout Unit there, they had a booth and Mr. Chuck Ruby, who works at Nassa and is a member of the Experimental Aircraft Association, had contacted me before and said that he had a boat and wanted to know if our Post would be interested in having this boat. And since we are not an Aviation Post, I mean we are an Aviation Post, we turned down his offer. But I said I thought a Sea Scout Unit might like to have it. So when I meant Dave Dickens at the Scout Show I told him about it. I gave him my card and fxxxldxxix he gave me nis card and I told him that I would get in touch with Chuck Ruby and give him his phone number. So it was a few weeks after that Dave Dickens called me and he asked if I had contacted Chuck Ruby about the boat and I told him no that I hadn't had time so he asked for his phone number and I gave Dave Chuck's phone number. So apparently he called Chuck and talked to him about it and about a week later Dave called me and told me that he had talked to Chuck and he was going out to look at the boat or something like that and that they would be interested in having it. So I said fine, terrific whatever y'all work out that's up to you. And then shortly after that I guess it must have been in January, I'm not sure about the date, but it was on a Saturday night my children were gone and Dave had called me several times after that just to chat and to see how things were going and talked about Scouting and this, that and the other. And he showed up at my door one night and he had a bottle of $\frac{V_0 d k A}{\text{Vonka}}$ with him und he said that ixxxxx he appreciated my putting him in touch with Chuck Ruby and getting the boat and things. Now I haven't talked with to Chuck Ruby I don't know if they actually got the boat or not. But I had been working out in the yard and

doing some other things so I said sit down and I went into my bedroom to change clothes and while I was changing the door knob starting turning and I just flipped the blot and blotted the door and he walked away. Well, it scared me and I wasn't sure to come out or not. But I went ahead and changed clothes and then I came out and we set on the couch and talked awhile and I mixed him a drink a Vodka Collins, that is about all I had, but I mixed him a drink and we talked and then he started talking about his family and his work in Scouting and told me that he had a lot time for Scouting work because he didn't work. He said that when he was in the service he had a lot of problems and they said that he wasn't suited for the service or something, I don't remember what exactly what it was, but he said he had a psychological discharge from the service and he was on full disability, so he didn't work he lived on his pension. And he said he had custody of three children because he said she was a nut, he said she was tattooed on her forehead, on her neck, on her chest and she had tattoos everywhere and several other things and she wasn't a fit mother and so he had custody of these three children. And then he started talking about Scouting and about kids and he talked about how kids more developed more matured earlier now and he said that the girls 12 years old looked like 18 years old and he said particularly the boys. He said boys are ripe now. But the way he said it made me wander. Just his whole manner and the way he was talking worried me. And he kept going about kids being mature and kids were having sex earlier and these girls who run around and see through halters and shorts things like that. He said they all dress so provocatively and how can a man resist even though she is . young and they all look so much older and you can't tell how really old they were. And then he talked about his ship and he said he had kids in his Post/Ship and that they had all dropped out and he said that he was going to recruit more kids. And he asked about helping out with my Post and I didn't think, I couldn't put my finger on it and said difficulty what was wrong but I had a hunch something was wrong, so I told him that we had all the Advisors we could use in our Aviation Post. So we talked for a few minutes more and exactully I

wanted to just to get him out of there. I told him I was tired and I had been working all day I thought I was going to go to bed early. And then the phone rang and it was a friend of my who works for Braniff and he is a young fellow and he knows that my children and I are there by ourselves and he calls me every night from work just to check to make sure everything is alright. So when the phone rang and it was I talked for a few minutes and I told him that a man was there I was talking to and he asked me if there was anything wrong and I said yes and well I am getting ready to leave work you want me to come by and I said yes definitely most definitely I would love that and I was trying not to let Dave Dickens know. So then when I hung up well I told Dave that was my boyfriend and is coming over and he said he thought you were married, I said no I'm not married and then it hit me I wandered if he thought I was married why did he show up at my door with a bottle of Vodka and you know. He asked me to go out with him. I knew then. And I hoped gets here quick. And so I told him that he was going to have to leave because was coming over and he said he would like to meet him and I said know you don't want to meet Allen I said he is big and ugly and mean and I was trying to be flippant but yet get him out of there. Because I was really by that time scared of him. And I just told him he would have to leave and he did and just as he was pulling out pulled in behind him and he got out of the car. And Dave just kept going because is a big fellow so came in and asked he asked me what had happened and I told him. So anyway he said if the guy calls me again he said just him and he will give him call and tell him to leave you alone. So anyway the next day Dave called me the next morning and he asked me to go out and I told him no that I couldn't go out with him and then I called Jack Bacardi and just asked him what do you know about Dave Dickens and he said well not a whole lot, then I asked him is he a Boy Scout Commissioner. And Jack said no he's not he wants to be but we just let him thinks he is but we don't want him to be he said I was going to recruit him as a commissioner as a volunteer until I found that he's not the type of person you want and he said that we just let him think he is or

whatever. So I told him what had happen and I said Jack there is something wrong with that man and frankly I think the man is dangerous. I said I can't put my finger on it I don't know why I said but I really don't like the man and I said I certainly wouldn't want him in our Post around my kids. So he said I will keep a watch a watch on him. So Dave called me several time after that several times and I finally told him I was getting married and he asked me if it was to and I said yes. I said are getting married and so he said well are you going to invite me to the wedding and I said well I don't know we'll see. And he called me several times after that but I told the receptionist, she could recognize his voice by that then, and she would tell he I wasn't there or I didn't work there anymore or whatever and I had had my telephone number changed. And that was about the last I heard from him. Somebody asked me if I knew Dave Dickens and I don't remember who it was and I said yes I knew him. And asked if he was one of the Advisors in my Post and I said no he's not and he said I ust wandered. But that's all there was and that's really all the contact with .Dave Dickens and I didn't want to talk to him and I didn't want to be around him. And I just don'tCLARK....in the course of his discussing his views or his outlook with about young people is there anymore that you can say than what you have already said either his views xxxxxxx toward young ladies or young men. ...well no he just said like boys being ripe the word he used was ripe at an early age and how was a man expected to turn something down when it's flashed in front of him like that like girls do that the young girls look so much older and you can't tell how old they really are. CLARK... can you tell me anything more about the conversation in connection with the custody of three children? ...well he said that he has custody of the three children because she is an unfit mother. CLARK...did he mention ...no, if he did I don't remember. He mentioned that she had been married several times I think and he had the children because/was unfit. He said she was tattooed all over her body. Oh, he said she had a rose on her ass, pardon me, but that's what he said. And she had a snake or serpent tattoo on her chest that went up

around her shoulders and then she had something tattooed on her forehead that went down and then back around her cheeks and had tattooes all over her back and her arms and CLARK...was there any mentioned as to where she lived? ... no not as I recall. CLARK...was there a mentioned as to if he had physical custody of these children. Do they live in the same residence as he does. ... they live in the same residence and I think he said he lives with an aunt an aunt lives there. As a matter of fact, he said something about his aunt thought he was going to be at a Boy Scout meeting or something like that because he didn't what her to know where he was because she worried about him too much or tried to keep too close tabs on him and he didn't what to up set her. CLARK... do you know where Mr. dickens lives? ...he said he lives in Higlands I think I have his card I don't if I still have it or not. I may have throw it away. I believe, I probably threw it away. - H. Mr. Dickens and the committee agreed to meet at 7:00 p.m., Monday, September 24, 1979, to resume discussions.


In the meeting, Mr. Dickens explained the following salient points.

I have been personally acquainted with the above individual in scouting, church, and in an attorney/client relationship since the latter part of 1974. I have worked with Mr. Dickens with the Eastern Division Scouting Jamboree held in September 1975 and have dealt with him in other scouting activities in his capacity as a Commissioner. When it came to knowing the rules and regulations of the Scouts, I found Mr. Dickens to be exemplary. He was also very innovative, helpful, and well-meaning in the activities that he helped me with in scouting. In my involvement with Mr. Dickens and others in scouting, I have never heard of Mr. Dickens being a violent, lecherous or a licentious person. The only complaint I ever heard about Mr. Dickens in his role in scouting has been one of being a little bit too eager and overbearing in implementing scouting programs or giving advice to scouting personnel.

I am presently representing Mr. Dickens in a custody fight with

you were to consult any attorney involved in custody fights, he would inform you that they get pretty dirty and that in many cases there are a lot falf-truths and false allegations made. I do know that since Mr. Dickens had the boys in his care and custody on a continuous basis from September 1978, the boys have vastly improved both in their physical appearance and well-being and in their demeanor and presence, and I attribute most of this to the love and stability that Mr. Dickens has given these two boys.

I do know to be a person who has distorted the truth on many occasions and also to be a person who is very unstable. I do know that Mrs.

As I stated above, I have known Mr. Dickens in three areas, scouting, church, and on a professional basis, over the last 4-1/2 years, and have not seen nor heard from any others that have had contact with him, anything to back up the allegations that is making against. In my opinion, I consider Mr. Dickens to be a person who is fit and proper to be a part of the Boy Scouts of America. If you will check Mr. Dickens' record with the Sam Houston Area Council and the East Harris County District, in particular, you will find no evidence of his ever being a violent or immoral person in any of his scouting endeavors. In fact, you will find that he has been awarded many awards for his scouting work.

Dear Dr. Dickson:

This letter is in response to our telephone conversation last week during which we discussed various accusations made against David Dickens by

As I recall, you were interested in my opinion as to the veracity of these charges and as to whether Mr. Dickens was emotionally or morally fit to continue working with boys and in the Boy Scout organization.

I have known Mr. Dickens for the past four to five years during which time he has been my patient at the United States Veteran's Administration Medical Center in Houston. I have come to know him fairly well during this time and what follows will be based on my experience with him during this time period. The first accusation you noted to me was that Mr. Dickens was violent, had, in fact, killed a man in the past and continued to be violent and dangerous. To the best of my knowledge, all of these statements are false. Whereas it is true that Mr. Dickens has a temper and, upon occasion, comes into serious verbal conflict with others, he has never, to the best of my knowledge, been violent or dangerous and does not constitute a risk of violence at present. The next accusation you related to me was that Mr. Dickens was morally unfit in that he consorted with many women and was an inveterate skirt chaser. To the best of my knowledge, this accusation is also false. Mr. Dickens has been involved with his current wife for most of the time I've known him and has been married to her for the past two to three years. To the best of my knowledge, there has been no infidelity or "skirt chasing".

You are probably already familiar with the circumstances surrounding the slanderous letter written by . I might add that this woman has also made threatening phone calls to both Mr. Dickens and his wife. The issue in question appears to be Mr. Dickens' attempts to provide a stable and healthful home for who were being extremely ill taken care of prior to his efforts. The court considering the case has already judged to be unfit currently as a mother.
