

May I refer you to your correspondence with Dan O'Neill of this staff re: the above individual. In December of 1967 - David L Jutras was involved in homosexual activities with a Scout or Scouts from Troop 15 Somerville, Massachusetts. He was then an ASM in the troop.

This matter was never reported to the National Council. Mr Jutras resigned from Scouting locally and faded into the shadows. To our knowledge he has not attempted to gain entrance into Scouting again. The above mentioned situation has just come to my attention. I therefore request that you immediately place David L Jutras on the confidential file.



As of this date we are revoking your commission in Scouting and request that you do not have any further contact with any Unit in the Movement.

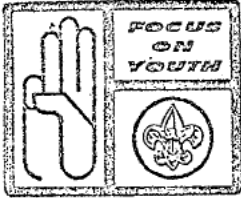
