DAVID MICHAEL ORMOND

DEFENDANT

The defendant, David Michael Ormond, having this day appeared in open court with his attorney, Hon. William B. Norment, Jr., and Hon. William F. Polk, Jr. having appeared as attorney for the Commonwealth, for the purpose of (a) the court's consideration of the presentence investigation report of the defendant, and (b) the court's fixing of punishment and imposition of sentence upon the defendant; and the Court having determined that the defendant heretofore entered a guilty plea in connection with the offense(s) charged in the indictment on May 24, 1984, which said guilty plea was on said date duly accepted and adjudged by the Court to have been made knowingly, understandably, competently, voluntarily, and with advice of counsel; and the Court having duly considered the contents of the presentence investigation report made of the defendant by the Probation Officer and having permitted the defendant and his counsel to review and fully acquaint themselves with the contents of said report in its entirety, and the Court having afforded the defendant and his counsel a fair opportunity and a reasonable period of time to controvert the factual contents and conclusions of the presentence investigation report;

and the Court having fully considered the possibility of probation and conditional discharge of the defendant and after due consideration of the nature and circumstances of the crime(s) and the history, character and condition of the defendant, the Court is of the opinion that imprisonment is necessary for the public because:

a disposition of the defendant upon probation or conditional discharge will unduly depreciate the seriousness of the defendant's crimes;

and the Court having inquired of the defendant and his counsel whether they had any legal cause to show why judgment and sentence should not be pronounced against the defendant; further, the Court having afforded the defendant and his counsel an opportunity to make statements in the defendant's behalf and to present any information in mitigation of the punishment and no legal cause having been shown why judgment and sentence should not be pronounced against him upon his guilty plea, it is therefore

ORDERED and ADJUDGED by the Court as follows:

That the defendant, David Michael Ormond, is guilty of the offense of first-degree sodomy committed between the period from January, 1980 to March, 1984, as charged in Count II of the indictment and his punishment therefor is fixed at imprisonment for an indeterminate term of twenty (20) years; accordingly, he is hereby sentenced to and ordered committed to the custody of the Department of Corrections for a term of twenty (20) years and until released in accordance with law.

That the defendant, David Michael Ormond, is guilty of the offense of first-degree sodomy committed between the period from January, 1980 to March, 1984, as charged in Count III of the indictment and his punishment therefor is fixed at imprisonment for an indeterminate term of twenty (20) years; accordingly, he is hereby sentenced to and ordered committed to the custody of the Department of Corrections for a term of twenty (20) years and until released in accordance with law.

That the defendant, David Michael Ormond, is guilty of the offense of use of a minor in a sexual performance committed between the period from January, 1980, to March, 1984, as charged in Count IV of the indictment and his punishment therefor is fixed at imprisonment for an indeterminate term of ten (10) years; accordingly, he is hereby sentenced to and ordered committed to the custody of the Department of Corrections for a term of ten (10) years and until released in accordance with law.

That the defendant, David Michael Ormond, is guilty of the offense of use of a minor in a sexual performance committed between the period from January, 1980, to March, 1984, as charged in Count V of the indictment and his punishment therefor is fixed at imprisonment for an indeterminate term of ten (10) years; accordingly, he is hereby sentenced to and ordered committed to the custody of the Department of Corrections for a term of ten (10) years and until released in accordance with law.


It is further ORDERED and ADJUDGED that the sentences imposed upon the defendant under Counts III, IV and V of the indictment shall run with and be served concurrently with the twenty (20) year sentence herein imposed upon him under Count II of the indictment.

It is further ORDERED and ADJUDGED that the defendant shall not be entitled to bail and that the Sheriff of Henderson County shall deliver the defendant to the custody of the Department of Corrections at his earliest convenience at such location within this state as the Department shall designate for the purpose of the defendant's executing the sentence(s) imposed upon him hereunder, and the defendant is now remanded to the custody of the County Jail, there to remain and be securely kept, until he can be transported to the custody of the Department of Corrections as hereinbefore provided.

I submit to you the results of an investigation conducted into the alleged misconduct of David Michael Ormond, Adult Leader Troop 316, Evansville, Indiana.

As a result of an investigation conducted by Detectives Dave Petrie and Don Ferris of the Henderson City Police Department, Henderson, Kentucky, David Michael Ormond was arrested on March 21, 1984, and charged in the State of Kentucky with ten (10) counts of Class A sodomy and one (1) count of Class C use of a minor in sexual performance and was placed under a (\$20,000.00) cash bond as a result of the charges.

I met with Detective Ferris and requested a copy of their arrest report. This request was denied at the present time as they felt that releasing any copy of this case file may have adverse effects on their case against Mr. Ormond, however I was allowed to read the original arrest report which stated in words to the effect, to-wit:



Defendant was arrested on warrant stating that Detective Petrie was advised by a male minor, whose name will be known to the Court that sometime during 1981, the defendant subjected him to sexual contact by forcible compulsion. The victim was under the age of eleven (11) years of age at the time of the offense.

I was also advised by Detective Ferris that a Grand Jury hearing was held in this case and as a result of said Grand Jury Hearing David Michael Ormond was indicted on two (2) counts of 1st Degree sodomy, one (1) count 1st Degree Sexual abuse and two (2) counts of sexual performance by a minor.

Mr. Ormond is presently being held in the Henderson County Jail.

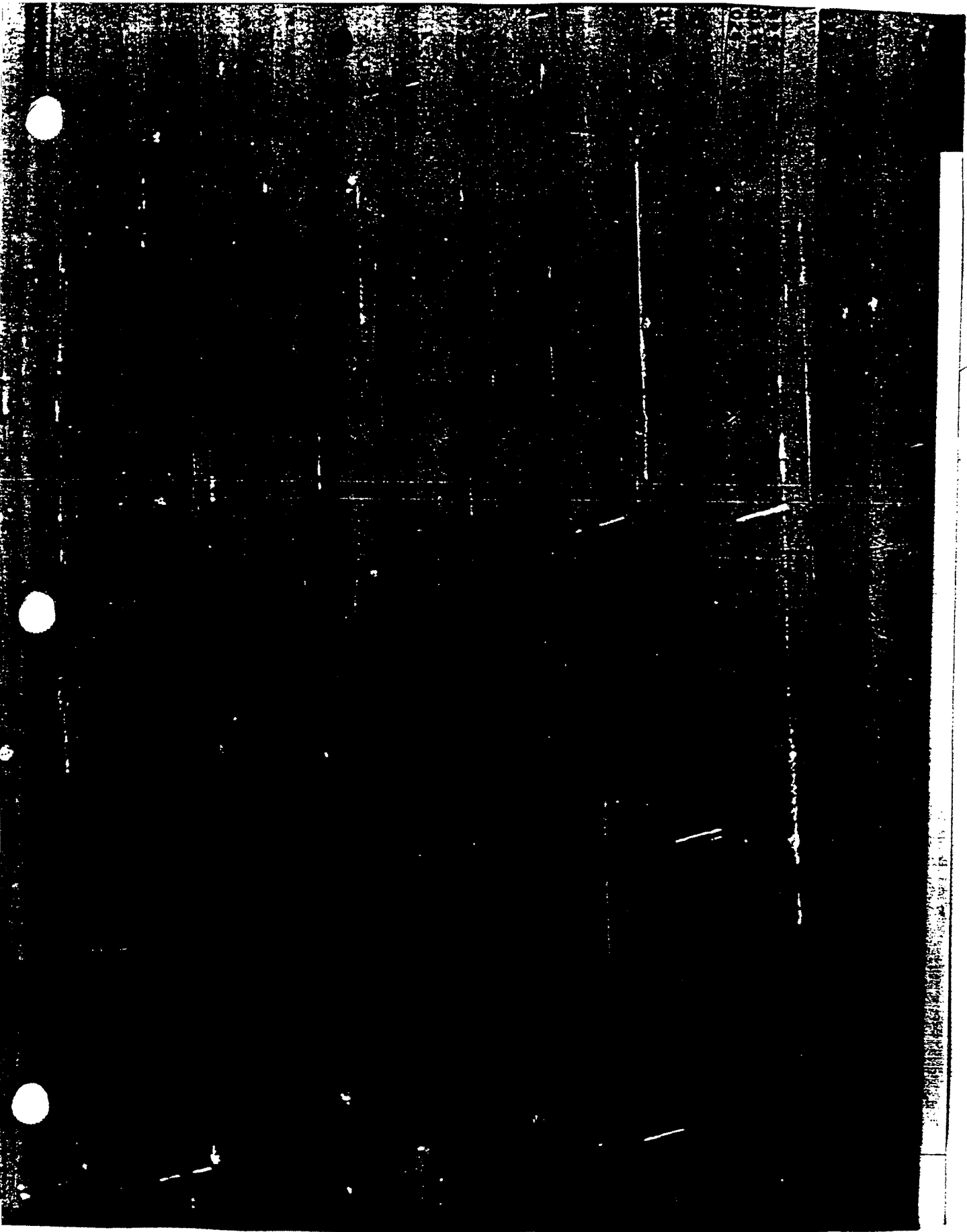

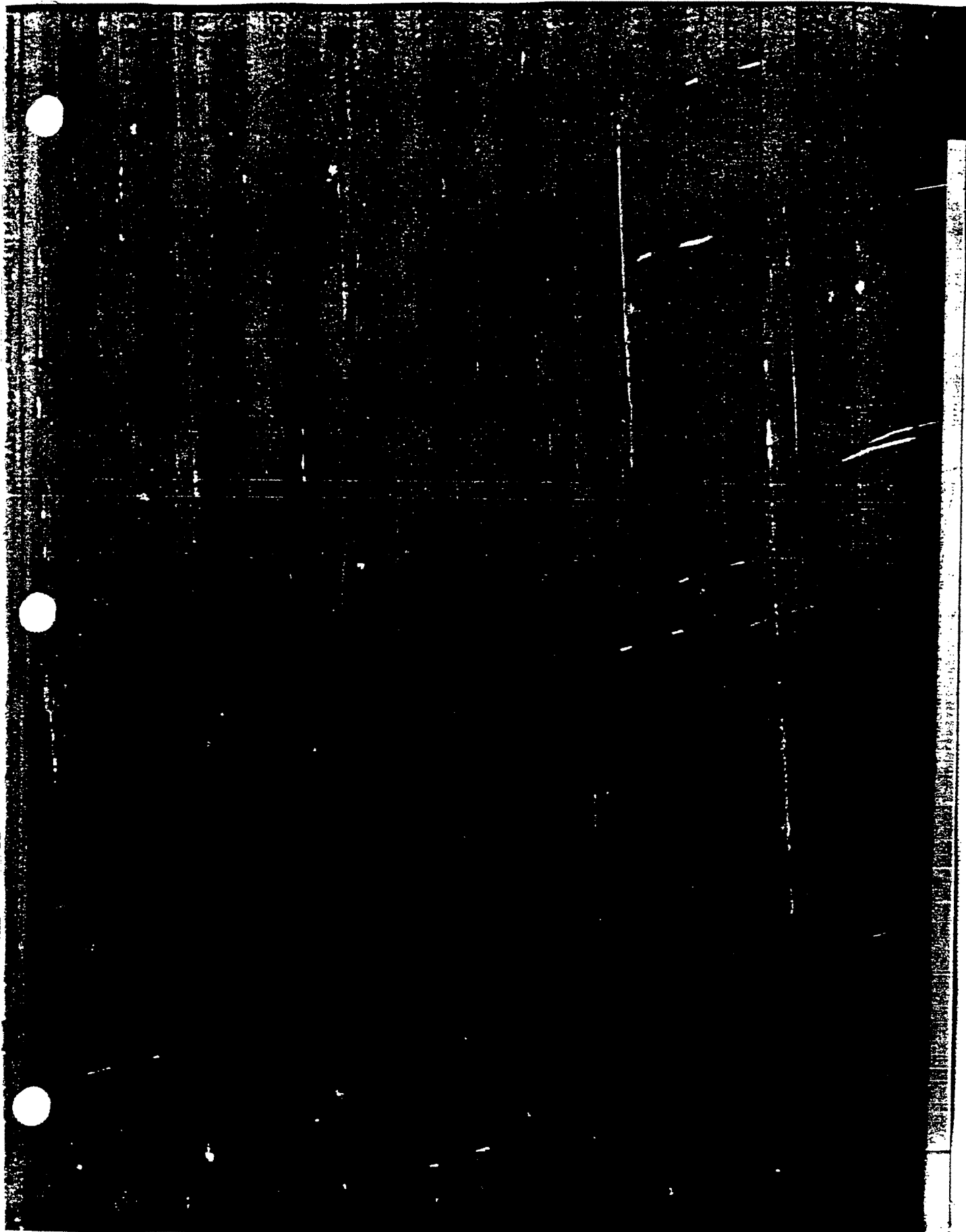
