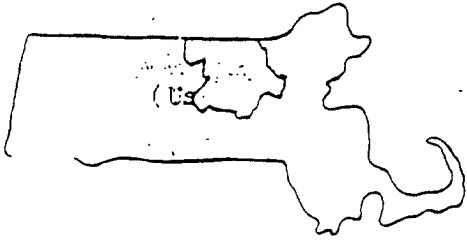

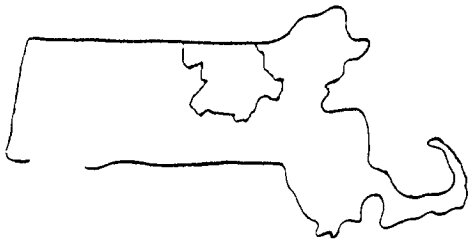

10/22/87 .Advised by Mr. Richard Conway (Board Member of the American Indian Society, Teacher, and Scouter in the Minuteman Council) that allegations of "child abuse" had been made against David Symonds (Member of their organization and the Nashua Valley Council) by a young adult who is also a member of both organizations.

.Specific details and name of the "victim" are known only to Mr. Conway per agreement with the "victim."

.Details known:

1. Boy is currently 20 years of age.
2. Incidents have been occurring since age 12 up to 2 months ago.
3. Boy is currently under professional counseling.
4. Others may have been or be currently involved but no names or facts are available.

10/23/87 .Established credibility of Mr. Conway with Scout Executive of Minuteman Council.

.Notified Council President and Area Director.

.Contact local police and Department of Social Service for clarification of required reporting procedures given age of young adult and confidentiality of victims name.

.Contact Mr. Conway to discuss details of situation and pending actions of the American Indian Society. He will advise us.

10/26/87 .Reviewed situation with Area Director and contacted National Legal (Park) for clarification on procedures.

.Advised by Mr. Conway that American Indian Society had voted to suspend Mr. Symonds membership in their organization and that he would be advised on 10/28.
