Molester gets 6 years

A Broadview Heights man was sentenced to six years in prison yesterday for sexually molesting five boys and girls, ages 7 to 12, whom he had met through his former job as a volunteer counselor at Bethel Temple Church in Parma.

David Korecky, 23, of W. Royalton Rd., pleaded guilty to fondling and touching the children while he either took them on camping trips or baby-sat them between March and October last year.

Korecky, who had been found guilty of child molestation in Santa Rosa County, Fla., in 1986, was indicted on the new charges last December. He avoided prosecution for five months until he was arrested in May by Geauga County deputy sheriffs.

Cuyahoga County Common Pleas Judge Burt W. Griffin, declaring Korecky should be kept off the streets, "for a very, very long time," sentenced him to six consecutive one-year prison terms.

Griffin said there should be a national registry of pedophiles that church and youth organizations could check before hiring people to work with children.

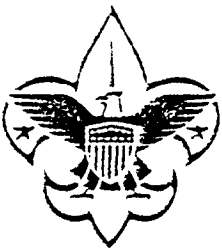
