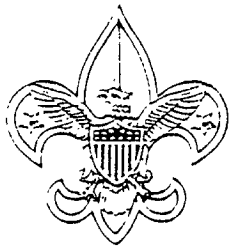




Dear Mr. VanSwearingen:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are, therefore, compelled to request that you sever any relationships that you have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that B.S.A. membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern an individual may not meet the high standards of membership which the B.S.A. seeks to provide for American youth.

If you wish to have this decision reviewed by a Council Review Committee, please write to me within sixty days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a B.S.A. member should be reinstated. The procedures for review of this decision are enclosed.

APPLICANT PROCEDURE FOR REQUEST  
FROM REVIEW OF DECISION DENYING REGISTRATION

1. If registration is refused, the applicant may request a review of this decision. This request must be in the form of a written request from the individual which includes his or her version of the facts supporting the claim that registration should not be denied.
2. Upon receipt of the written request for review, the President of the local Council shall appoint a committee to review the situation.
3. The appointed committee should review the facts as presented and, in addition, may interview any persons whose testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. A confidential report will be given to the applicant setting forth the decision of the committee.
5. The applicant may, if he or she does not agree with the decision, request review from the Regional Director.
6. If the regional review does not satisfy the applicant, he or she may ask for further review by the National Council. Decision by the National Council is final.

**Avoiding Child Abuse in Scout Camps.** It is possible to reduce the risk of children being abused while they are participating in the camping program. As is usually the case in Scouting, the key is adequate adult leadership.

August 1988

7:00 P.M.

Beginning in Oct/Nov, my son [redacted] attended a lecture (informal talk) at his school about Boy Scouts. His teacher's name was Mrs. Van Sweringen. Mr. 'Van' made contact with my son and [redacted] expressed desire to join. He was 10 yrs old at the time and was told he could belong to Mr. Mike Grien pack from Union Ave. United Methodist Church. Mr. Van made an exception and allowed [redacted] to also join his troop "unofficially". It was going Tues. + Wed. nights.

[redacted] and Mr. Van spent a lot of time together at my apartment. I estimate he's been there 10-12 times staying as long as 3 1/2 hours. Some of the time was spent helping [redacted] with projects; most of the time was spent talking with me. I felt uncomfortable with him being over at my house at night alone because I live alone. At first I felt very flattered that someone would spend a lot of time with my son, but also felt uneasy.

[redacted] left Wabos + was promised to Scout. When he began going to Mr. Van's troop exclusively, he began to find excuses not to go to Scouts.

He became edgy when Mr. Van came to the apartment. I never knew when he would come over. He would sometimes interrupt family routines (showers) and [redacted] would seem really upset by those visits where he would go so far as to hide in his room.

When camp time came up, [redacted] decided he didn't "feel comfortable" going. Mr. Van came by the apartment early Sat. morning & had a "check" with [redacted] in his room, alone with the door ajar (after I opened it). [redacted] decided at that point he wanted to quit.

During our discussions, I found him unwilling to make me a part of the setup. As many opportunities that there would be to let me know to provide my own "father-surrogate", he would attend events by himself, because we weren't informed ahead of time.

Against my expressed opinion, he continued playing D&D (Dungeons & Dragons) with the troop. [redacted] felt the physical contact while playing that he didn't feel "comfortable" with it. Specifically he would become vague so anything actual physical didn't properly happen, but I do feel the opportunities and the "threat" was felt by my son. Also, during swimming at the lake he felt that the playing got "out

of hands." I asked if anyone touched him.  
and he told me that "I think he tried"  
[redacted] got home late that night and told me  
that when he complained about some of the other  
children's behavior - Mr. Davis replied that "he  
wasn't any 'copypaster'" and he was the only supervising  
adult at the time.

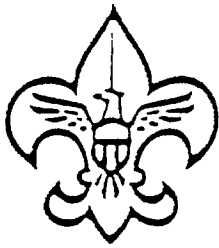

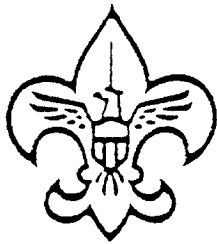

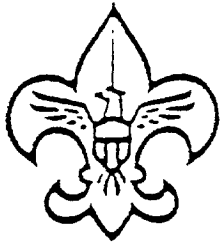

At a Scout Committee meeting of Troop 59 held on August 23, 1984, at 8:00PM, the following people were present: Rev. Paul R Tobin, pastor; Deacon Ron Sherwood, Institutional representative; Mr Frank Dixon,

In response to the recent report about Scoutmaster David Van Swearingen, the Committee felt obliged to make some observations concerning the circumstances and to offer recommendations regarding future procedures. Exact dates and details are omitted: the general guidelines, however, are spelled out.

Observations:

1. There was poor judgment in that the Scoutmaster left camp with the scout when the parent rightfully expected the scout to remain in camp.
2. There was a failure to notify the parent about the change in location or to bring the scout home.
3. There was a presumption on the part of the Scoutmaster to act without the parent's permission.
4. There was negligence on the part of the Scoutmaster in allowing himself to be in circumstances that could be construed as compromising or damaging.
5. There was the unfortunate result of the scout being listed on a police report.
6. There was a bad judgment on the part of the Scoutmaster in involving the scout's grandparents causing them to become upset.
7. There was an excessive amount of time spent with scouts both in scouting and other activities.

Recommendations:

1. That in response to the above observations some appropriate action be taken by the Scouting Committee.
2. That there be imposed on the Scoutmaster a period of probation for six months, beginning September 1, 1984. During this period the regular activities should be carried on by the Scoutmaster, but during this time dealing with parents should be carefully monitored.

3. That efforts be made to procure an assistant Scoutmaster and other adult advisors.
4. That a letter of apology be sent to the Committee at Regina Coeli by the Scoutmaster.

In light of the support of the parents of the scouts and the confidence of the Committee and the loyalty of the Scout Troop it is felt that the removal of the Scoutmaster would be an extreme and undesirable response.

It is the sincere hope of the Scouting Committee at Regina Coeli Church that Troop 59 be enabled to continue to function basically in tact and that the Scoutmaster be retained for the foreseeable future.
