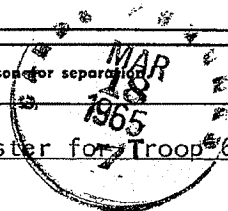

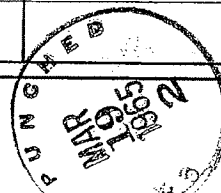

Your letter of April 6, addressed to Mr. Wilson, concerning David W. Henn, Scoutmaster of Troop 622, has been referred to me. We have placed this information in our files and have taken steps to have Mr. Henn's name deleted from the Troop roster.

Your letter states that you have written statements supporting the charges against Mr. Henn. We would very much appreciate your sending us these substantiating statements so that we may have them in our files for future reference and to strengthen our position in refusing to accept Mr. Henn's future registration. Enclosed is a confidential record sheet which we would appreciate your completing and returning to us as soon as possible, together with the above requested substantiating documents.

This additional information will enable us to identify Mr. Henn should he ever again attempt to register in the Scouting program. Thank you for your cooperation in this matter.

I am sure you realize that this leaves Troop 622 without any registered unit leader. Undoubtedly, someone is taking over in this position. In order for the unit to continue to receive program inserts in Scouting Magazine, it will be necessary to advise this office of the name of the new unit leader. This should be done by filing with us an additional enrollment for this individual in his new position. Please do not file a separation notice as we have already dropped the current leader.

We regret to report that David W. Henn, Scoutmaster of Troop 622, Gulf Coast Council, has been dismissed by the Troop Committee because of homosexual acts involving boys in the troop. We have supporting this action written statements sent to us by the Escambia County Juvenile Court. It is our desire to see that Mr. Henn be denied any future opportunity of participating in the Boy Scout movement.

Mr. Henn's address is 505 N. 48th Avenue. He is 26 years old, a member of the Lutheran Church and works as a chemist with Newport Industries. He is not married. Prior to coming to Pensacola, he lived in Jacksonville, Florida.

Please notify us if we need to take further action in the matter.
