Dear Judge Buckingham:

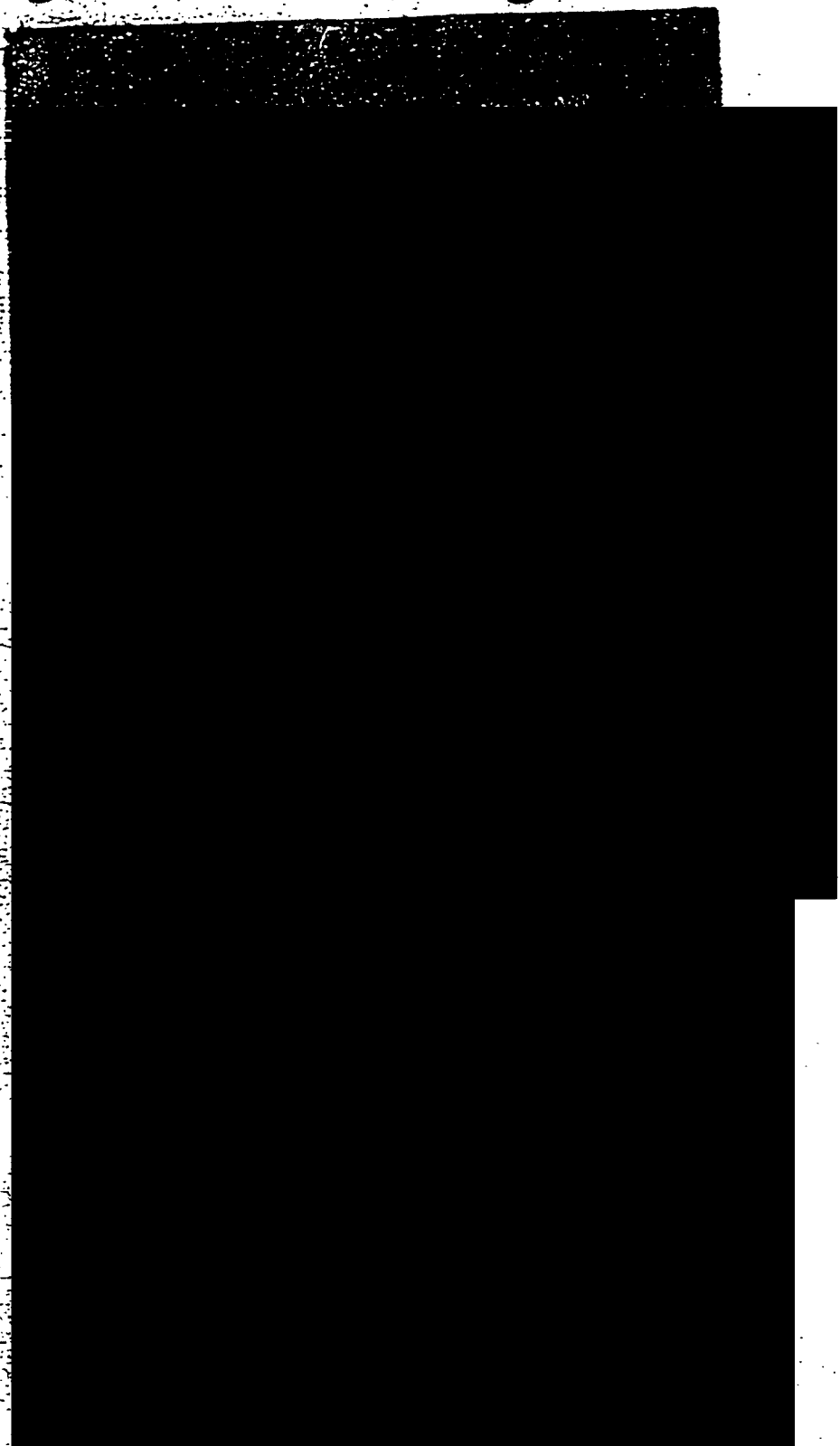

He has kept his appointments faithfully and cooperated with treatment.  My name is [REDACTED], and I live at [REDACTED]
Murray, Calloway County, Kentucky, with my [REDACTED]

 On Sunday, January 30, 1983, around noon, my sons,
[REDACTED], came home from playing at
Belmont Park, which is close to our house, and told my wife that
a boy named David had pulled down their pants and played with
their penises. I woke up about 45 minutes later and my wife told
me about it and I questioned the boys and they told me the same
story. I took [REDACTED] with me, and we walked down to a house at
[REDACTED] and he pointed that house out and told me that
it had happened in a treehouse behind that house. I sent [REDACTED]
on back home and I went up and knocked on the door and talked with
a man who lived there. I asked him if he had a son named David
and I then told him what my boys had told me and he called David
outside and asked him if he had done that to my boys and David
admitted that he had. I then told David that I did not want him
over around my house or around my boys any more and left.

 I have since learned that "David" is in fact David
Wayne Robinson who lives at [REDACTED] with his parents
and that he was born in 1964.


