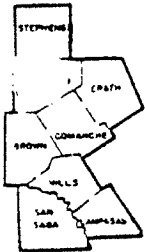
Dear Paul,

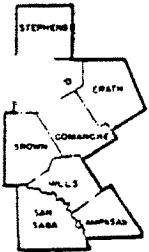

Coaches are asked to report to the site at 9:00 a.m. and registration and draft of third and fourth graders will begin at 9:30.

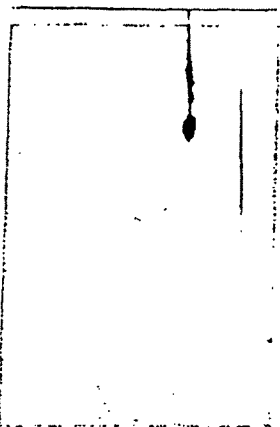
Fifth and sixth grade draft will begin at 10:00 a.m.

The fund will aid the Combs family in defraying medical expenses connected with six years of treatment for their 11-year-old son, Lloyd E. Combs who suffers from a malignant tumor of the brain.

Young Combs underwent surgery for fifth time at St. Joseph's Hospital in Fort Worth last week.

At last report, he was progressing in the hospital's ICU section and it is hoped that he can be released on an out-patient basis in a short time.

He will return to the hospital daily for treatment.

His father is auto mechanics teacher at Glen Rose High School.

Persons wishing to donate to the fund may do so in the name of Lloyd Combs at First National Bank in Glen Rose.

Cowan said that seven members of the local American Legion Post had contributed a total of \$50.00 to open the

Man Jailed For Juvenile Enticement

David Wayne Cunyus, 48, of Stephenville, Va., jailed here Sunday evening on two charges of displaying pornol material to a minor and six counts of enticing a minor.

The investigation and arrest followed notification to the sheriff's department by a local resident that the suspect was apparently attempting to lure youth teenage boys into his van.

An inventory of the vehicle following his arrest revealed a collection of sexually explicit material.

Cunyus was held in Somervell County Jail Monday night in lieu of bonds totalling \$12,000.00 and was released Monday after posting bail.

Local officials remind parents to warn their children against associating with strangers accepting gifts from persons unknown to them.

Class A misdemeanors are punishable to a maximum of one year in jail and/or \$2,000.00 fine and Class B offenses carry a maximum penalty of six months in jail
