I just received a letter from Mark Willey, concerning the above named individual, but he really had no information. He indicated he had talked to a lot of people, but could find no information concerning this man.

The only information we had previously was your letter to Mr. Okerlund indicating that he had been convicted on a child abuse charge and served time as a result of this. You also indicated that he had tried to register apparently on the district level in D8614. Your letter was dated May 24, 1988.

All I really want at this time is a Confidential Record Sheet that would help us to identify Mr. Okerlund should he try to register in some other location. Is there anyone that knows what he looks like, approximately how old he is, and his race? Information of this type would help in our identification process.


