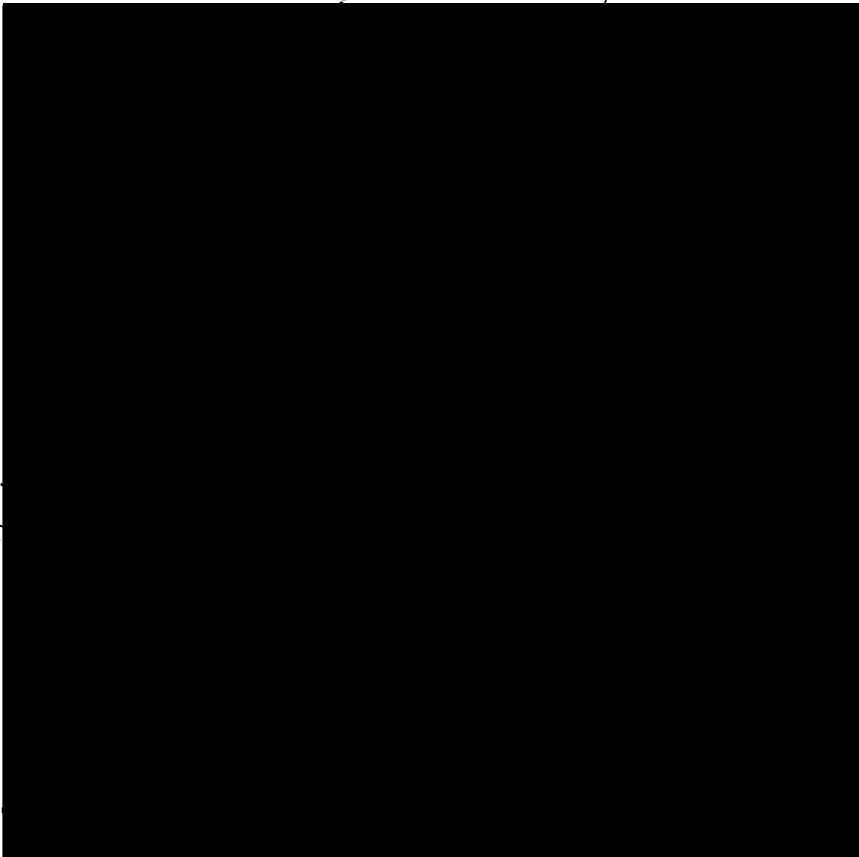

Dear Paul:

Enclosed is a letter stating that Dennis "Gene" Garrison has been involved in activities that we believe disqualify him from being a leader of young men in the Boy Scouts of America. I met with Gene Garrison on Monday, July 14th and told him that we had a signed statement that he had placed his hand on the genitals of a Scout. Gene's response was that he knew that once this kind of accusation was made that it was not worth fighting. I talked with Gene at some length and am convinced in my own mind that he should not be permitted to continue his registration with the Boy Scouts of America. He was told that he would not be allowed to participate in any manner in Scouting and accepted this and immediately left camp.

Gene transferred to the Istrouma Area Council in 1981 and served as an Assistant Scoutmaster in Donaldsonville, Louisiana. In 1983 he became a Unit Commissioner and is registered in that position at the present time. Prior to coming to Baton Rouge, he served as a Unit Commissioner for Troop 124 and Pack 324 in St. Elmo, Illinois. Prior to that time he was involved in Scouting but I am not sure in what capacity. It was in the Illinois area. His date of birth is March 10, 1950. He is a Vigil member in the Order of the Arrow and very active at all council, area and national OA functions. He is presently registered for the OA Conference this summer and was told that he would not be able to participate. Gene is approximately 200 lbs., 6' tall, dark brown hair and eyes, not married, and employed by Exxon Company, USA and works off shore.

Paul, please advise if additional information is needed.

On the morning of June 24, 1986 (Tuesday), [REDACTED] was in the staff lounge alone. Gene Garrison entered the staff lounge. He greeted [REDACTED]. As [REDACTED] was leaving the staff lounge, he passed by Gene and was pinched in the rear by Gene. [REDACTED] told him to stop and then rushed out.

That evening around 11:00 P.M., [REDACTED] was in bed in his tent and had turned the lights out. He was getting ready to go to sleep. Gene walked into the tent and greeted [REDACTED]. He sat on [REDACTED] bed. He proceeded to lecture [REDACTED] on having his radio on. After about two minutes, Gene placed his hand on [REDACTED] genitals and attempted to stroke them. [REDACTED] jumped up and slapped him and told him to get out.
