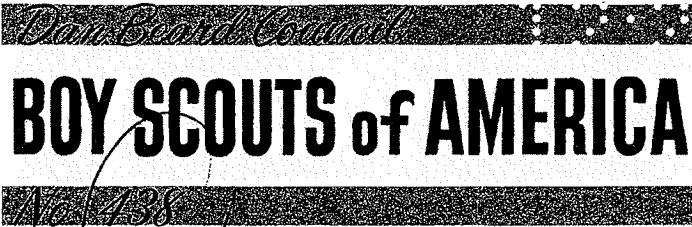

Dear Mr. Zenz,

This letter will confirm our recent conversation concerning the indecent liberties taken by Mr. Dennis Haskamp when he held the position of assistant scoutmaster in Troop 601.

Mr. Haskamp's indecent actions were called to the attention of Mr. [REDACTED], Committee Chairman and Mr. [REDACTED], Scoutmaster Troop 601, by Mr. [REDACTED] who claimed his son was subjected to Mr. Haskamp's advances during a campout at Mr. Haskamp's farm in October 1967.

Mr. [REDACTED] was in attendance at this troop meeting. Mr. [REDACTED], Mr. [REDACTED] & I went to Mr. Zenz's home to ask for advice. Mr. Zenz warned against any accusations without proof. Mr. [REDACTED] checked with Mr. Haskamp's past scoutmaster who gave Mr. Haskamp a 'clean bill of health'. Mr. [REDACTED] & I interviewed two boys who were implicated by young [REDACTED]. These boys claimed no knowledge of any indecent actions by Mr. Haskamp.

Mr. [REDACTED] decided to slowly eliminate Mr. Haskamp from all troop activities except where other adults were present.

At summer camp, July 1968, I chanced to hear a comment by scout [REDACTED]. Upon questioning [REDACTED] acknowledged the indecent advances and actions of Mr. Haskamp. I then notified Mr. [REDACTED]. However before any official action could be taken [REDACTED] told his mother of Mr. Haskamp's actions and she in turn reported to Mr. Frank Dasenbrock and her son - a part time policeman in Cheviot.

Upon confrontation the two boys who were earlier questioned by Mr. [REDACTED] and me broke down and admitted the indecent actions of Mr. Haskamp. Three warrants were issued for his arrest. He was bound over to the Grand Jury in Cincinnati. His trial is set for Jan. 6th, 1969.
