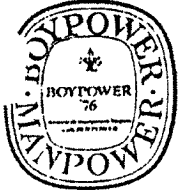

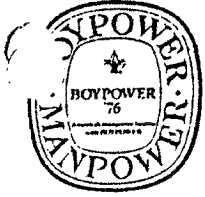


Dear Earl:
