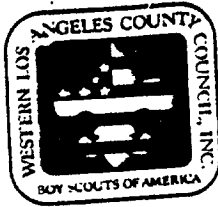





Confidential Report for Gene Richey

Subject: Dennis Walter Schult

The first I heard of conviction or related charges of Dennis Schult was on Wednesday, Feb. 20, 1991, when David Vallens of the Balboa Oaks District called to tell me he had read an article about this in the newspaper.

Later in the day I asked Lou about it and he informed me he was already aware of the article.

I have also spoken with Bart and he had no prior knowledge of this individual or any incidences.

On Thursday, Feb. 21, 1991 I received a request from David Russon, Director of Field Services to research this individual. David and I immediately called registration and found-out the individual was not registered anywhere, currently.

Later that afternoon, I spoke with President Garrick of the Chatsworth Stake. He requested that our conversation be kept highly confidential. I assured him it would be handled in this manner.

The following information, he related to me, was to the best of his knowledge:

About 10 years ago there was an incident involving Dennis Schult. The L.D.S. Church Ward Leadership (Chatsworth 2nd Ward Unit Numbers 535) at the time, decided to remove Dennis from all leadership positions in the church and in the church sponsored Troop. The positions Mr. Schult may have held at the time were Young Men's President and Scoutmaster. He was uncertain as to the exact positions Schult held.

Around 1987 another problem occurred with Schult and he was completely excommunicated from the L.D.S. Church.

To President Garrick's knowledge, Schult had not been a leader in Scouting after the incident 10 years ago. He also thought the incidents for which the charges were brought occurred within the last several years. He also felt that Schult should never be allowed to register in the Boy Scouts again. This concluded our conversation.

I then checked the registration records for Pack, Troop, Team and Post 535. This is what I found:

On the 1977-1978 Charter he was registered as a Scoutmaster in Troop 535.

On the 1978-1979 Charter he started-out being registered as a Scoutmaster for Troop 535 but that was later crossed-out and changed to a member of the committee.

On the 1979-1980 Pack Charter he was registered as a Cubmaster.

I was then surprised to find him again on the 1984-1985 and 1985-1986 Pack Charter registered as a Webelos Leader.

At no time was he registered in either the Post or Team.

I called President Garrick back and shared with him the fact that Schult had been registered as a Webelos Leader in 1984 and 1985. His comment was that someone clearly, relaxed.

He still thought the charges against Schult were for incidents that occurred from 1988 to 1990 after he was out of scouting. However, he felt the boys involved, Schult probably first met through contact in

the L.D.S. Church Scouting Program.

## Ex-Scout Leader Gets 8 Years for Molestation

A former Northridge Boy Scout leader pleaded no contest to two counts of child molestation and was sentenced to eight years in state prison, the Los Angeles County district attorney's office said Tuesday.

Under a plea arrangement, six other molestation charges against Dennis Walter Schult, 55, were dropped. Schult, who was sentenced last Friday in San Fernando Superior Court, was accused of molesting two boys, aged 8 and 12, over a period of several years at his Northridge house.

Prosecutors said Schult, an insurance agent and a car buff, often had young boys at his home. "They would work on cars," said Deputy Dist. Atty. Steven Ipsen.

But Schult also gave the boys "alcohol and showed them videos and magazines of a sexual nature. These things were used as tools to seduce and gain the cooperation of these children," Ipsen said.

Schult met one of the boys through a church scouting program. Schult was arrested last April after the two boys "realized what had been done to them. They also expressed concern about protecting other young children," Ipsen said.
