We have not heard from you since early June when you sent us material indicating that Mr. Laws is a hard core sex offender. He apparently is in prison at this time and should not be registered with the Boy Scouts of America.

We would like any newspaper clippings available, if you could secure them, so that we have more substantiation related to this situation. This would certainly support us in the future should neither you nor I be in our present job.

I am enclosing an Ineligible Volunteer Record Sheet which I would like to have completed, if you could get someone to help you do that. This is important since this is quite a common name and once he is released from prison, we would not be able to identify him unless we have this information.


