SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

The above named defendant was arrested for the following reasons:

Based on information received by the undersigned by the 13 year old female victim's parents regarding the above defendant secretly meeting with the above victim without the parents consent, a stake out was set up to watch the victim's activities. At APPROX 1936 hours on Thur 3-31-88 the defendant showed up in a wooded area west of the victim's home shortly after the defendant showed up the victim exited her back sliding door and walked towards the wooded area the defendant was in. At that time the undersigned identified him self as a police officer and approached the victim. The defendant was also located hiding in the woods and placed under arrest Ref Case # 883034. The victim was transported back to the PSL PD and questioned. The victim gave a statement stating that she was in love with the defendant since Nov. 1987 and had sex with him (5) five times, the last time being on the 22nd or 24 of March 1988 at his home at 192 Cristiana Ct PSL. The defendant was advised of his rights and gave a taped statement stating that he was in love with the victim since Nov however never had sex with the 13 year old victim. Defendant was transported to the S.L.C. JAIL.

PROBABLE CAUSE

SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT:

The above named defendant was arrested for the following reasons:

On the above date and time, the defendant, Donald Charles BECKER, did violate Florida State Statutes 856.021 and 790.01; TO WIT: Loitering and prowling and Carrying a concealed weapon, in the city of Pt. St. Lucie, St. Lucie County, Florida.

On 3-31-88 I was assisting Det. Gajkovich with a stakeout in the area of Whitmore and Thornhill Dr, PSL. Det. GOJKOVICH had received information that a 38 year old white male was going to meet with a 14 year old white female to engage in intercourse. DET. GOJKOVICH WAS POSITIONED DIRECTLY ACROSS FROM THE FEMALE'S RESIDENCE in a densely wooded lot. I was positioned in my unmarked police vehicle on the northeast corner of Fallon and Thornhill. At approx. 1920 hrs., the female exited the rear of the residence, walking west across Whitmore. Det. GOJKOVICH then advised me by radio that a W/M in the woods behind his location. Det. GOJKOVICH identified himself to the female as a police officer and escorted her back onto Whitmore. He then identified himself to the W/M in the wooded area and requested him to show himself, which the W/M failed to do. I began circling the area in my vehicle and requested additional back-up units. While checking I found the defendant's vehicle parked in the woods across from 1862 S [redacted]. [redacted] then responded back to the area of the wooded lot in an attempt to locate the W/M. At that time Det. GOJKOVICH observed the defendant attempting to conceal himself in the bushes. BECKER was brought out of the woods. Because BECKER ~~stayed~~ took flight from Det. GOJKOVICH who had identified himself as a police officer, was attempting to conceal himself, and was in a residential area after dark, BECKER WAS PLACED UNDER ARREST. While searching BECKER I found a double edged box knife in BECKER's right cowboy boot under his pant leg.
