

Jeffrey Gowing, 18, was sentenced by Clin-

ton County Circuit Judge Randy Tahvonen to four to 15 years in jail, and Donald Bushard, 20, was - sentenced to 8 to 15 years.

"We hope this can now be put behind us, so the people of Wacousta can pick up the pieces and get on with their lives," Clinton County Prosecuting Attorney Jon Newman said after Monday's sentencings.

Bushard, of 9383 Cutler Road, and Jeffrey Gowing, of 9401 Cutler Road, will be sent to Riverside Correctional Facility in Ionia for young offenders.

They pleaded guilty last month to third-degree criminal sexual conduct for molesting a 13-yearold troop member in two separate incidents.

Newman\_said he understood Jeffery Gowing - received the lesser sentence because the prospects for his rehabilitation were greater.

The prosecutor said that after

the judge noted the need to protect society against criminal behavior. Tahvonen told the youths their convictions did not "close the door" to changing their behavior, which would be up to them.

# 2 more sentenced in Scout abuse case

ST. JOHNS, Mich. — Two men active in Wacousta, Mich Boy Scout Troop 60 were sentenced in Clinton County Circui Court for sexually assaulting members of the troop.

Jeffrey Gowing, 18, son of former Scout leader Donald Gowing received four to 15 years in prison yesterday. And Donal Bushard, 20, a friend raised by Jeffrey Gowing's uncle, Delmar was sentenced to eight to 15 years.

Both had pleaded guilty to reduced charges of third-degre criminal sexual conduct. According to the State Department o Corrections, Gowing will be eligible for parole in September 1988 Bushard in December 1991.

Two weeks ago in the same courtroom and as part of the same case, the twins Delmar and Donald Gowing, 47, both former Scouleaders, were sentenced to 50-to-75-year terms for first degree criminal sexual assaults against Scouts from Troop 60.

"You befriended and betrayed these youngsters," Circuit Cour Judge Randy L. Tahvonen told Jeffrey Gowing. "Two weeks ago your father wanted the court to forgive him and it couldn't suspect he will die in prison. You won't and that's one price the court won't require you to pay."

Gowing responded that he wanted to say he was "sorry to the families of the victims" and "wanted to pay his debt to society and "so a mith his life."



Tanvonen noted that seven of Gowing's teachers and a school counselor wrote letters stressing Jeffrey's conscientious attitude. 3.25 high school average and college ambitions. One letter from a victim's family expressed hope that Gowing would receive therapy and not prison.

"I think there was a difference in the sentencing (between Bushard and Gowing) because of the judge's thoughts on

rehabilitation (for Gowing)," said Gowing's attorney.

However, Clinton County Prosecutor Jon Newman said that both men deserved the same sentence and that Gowing has been denying a problem at home between himself and his father. "I'm convinced that (Gowing) was attacked by his father and uncle," Newman said. "I don't see that Jeff is any more salvageable... than Donald Bushard. The damage has been done."


