The Tippecanoe County Probation Department files a pre-sentence report and a copy of same is provided to defendant.

Sentencing hearing held. The Court considers pre-sentence report and being duly advised now accepts the defendant's plea of guilty. The Court now enters a judgment of conviction that defendant Donald G. Duncan, a male, 43 years of age, is guilty of the crime of Sexual Battery, a Class D felony of the information filed herein.

The Court imposes the following sentence, to-wit:

(1) Defendant, Donald G. Duncan is ordered committed to the custody of the Indiana Department of Corrections for classification and confinement for a period of 1 1/2 years.

(2) No fine is imposed.

(3) Defendant is assessed court costs in the amount of \$113.00.

(4) The Court finds that by reason of the character of the defendant and the facts and circumstances surrounding the commission of said crime, the interest of society does not demand or require that defendant shall suffer the penalty imposed by law. Accordingly, the sentence of incarceration is suspended and defendant placed on probation for a period of 1 1/2 years to be supervised by the Tippecanoe County Probation Department upon the following terms:

- (f) participation in and successful completion of the emotional or substance abuse counseling program as recommended by the probation department and payment for such program;

(g) defendant have no contact directly or indirectly with [REDACTED] [REDACTED] during term of probation;

(h) H.A.-The Court orders the defendant committed to the Tippecanoe Community Corrections Department to serve 120 days on house arrest beginning on the first available date without credit for good time, upon such terms and conditions as designated by said department. At any point the defendant is rejected by said department, the defendant shall serve the balance of the sentence in custody of the Indiana Department of Corrections.
