Thanks for your help in completing this matter.

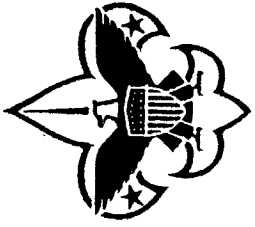

At about 10:00 p.m. on March 20, 1990, I received a telephone call from a Mr. Vern Greene, [REDACTED], Medina. Mr. Greene was calling for [REDACTED], a neighbor without a telephone, who alleged that her son, [REDACTED], had been molested by his Scout leader.

[REDACTED] stated that the leaders name was a Mr. Kroyer and that unit level meetings were held at St. Francis Catholic Church.

Next, I contacted the District Commissioner to obtain the unit number, position, and directory information. I gave no indication to the District Commissioner as to why I was requesting the information.

After a brief telephone conversation with D. Russell Weaver, council Scout executive, I contacted the Medina County Sheriff department and Medina City Police Lt. David Shows. The assistant Cubmaster, John D. Kroyer, alleged to have been involved, lives in Medina at [REDACTED] registered in Cub Pack 3506.

Returning a call to Mr. Greene and [REDACTED], I agreed that it would be prudent for them to make direct contact with the Sheriff's department.

Later that evening, I received a call from Lt. Shows indicating that Medina City Police had interviewed [REDACTED] and Medina City Police department would handle the case.

The alleged incident was to have taken place at a den sleep-over three weeks earlier.



Dear John:



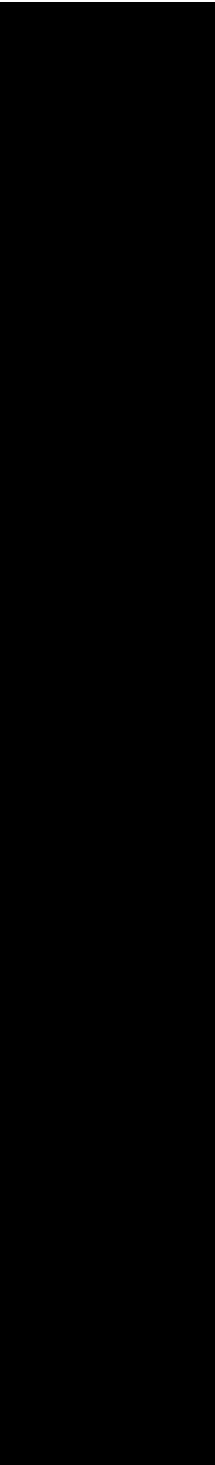
