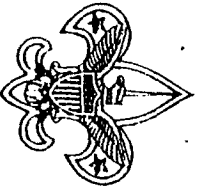

# Plea entered on sex abuse charge

**PAYETTE**—An area resident has pleaded guilty to two counts of felony lewd conduct with a minor under age 16 in Idaho 3rd District Court in Payette. Douglas Lee Higley, 47, entered the pleas Friday before Judge Wayne P. Fuller.

Higley is currently employed

as a baker for D'Alessandro's in Elko, Nev., but said he regularly commutes between work and Payette where his wife and four children reside.

He is accused of sexually touching a minor child during the summer of 1985.

Higley told the court he has voluntarily sought help and counseling through the Church

of Jesus Christ of Latter-day Saints and a private therapist.

He said he was doing all that he can to cooperate and make amends. He said he believes the victim is also receiving counseling.

Fuller set sentencing for Nov. 27, allowing Higley to remain free on his own recognizance with special conditions to have

no contact with the alleged victim.

Payette County Deputy Prosecuting Attorney Greg Frates asked that Higley not be allowed any unsupervised contact with minors. Fuller said he would follow the recommendations made by Higley's counselors.

If convicted, Higley faces a maximum term of life in prison and a fine of \$5,000 or both.
