Dear Paul:

Recently the Council was inf [redacted]
involved an 18 year old boy [redacted]
is Earl J. Shanklin, formerly of [redacted] Wilbraham, MA, currently
moving back to the Baltimore area with [redacted] (no address)

The youth has been living with [redacted] at the Wilbraham
address since August, 1988. Apparently the [redacted] are friends with the
Shanklin's and when Earl had problems living with his adopted parents, they
sent Earl to live with the [redacted].

About two months ago [redacted] became aware of two (2) incidents of possible
child molesting occurring in May, 1989. The first incident involved a
neighborhood youth of approximately 12 years of age in which Earl had the boy
remove his shoes and socks. The second incident involved another community boy
of about the same age in which he (Earl) had the youth remove his shoes and
socks and placed his bare foot in Earl's genitals.

When [redacted] confronted Earl Shanklin with these allegations, Mr. Shanklin
admitted to them. [redacted] and Mr. Shanklin went to the second youth's home
and met with the parents and apologized.

Since that time, Mr. Shanklin has been returned to his [redacted] in
Baltimore and they have placed him under psychiatric counselling through the
LDS Church.


Although neither of the incidents involved scouts, [redacted] informed our
Council and the Baltimore Council and has asked that Earl Shanklin be placed on
the Confidential list.

Since learning of these incidents we have reported it to the Department of
Social Services as prescribed by law.
