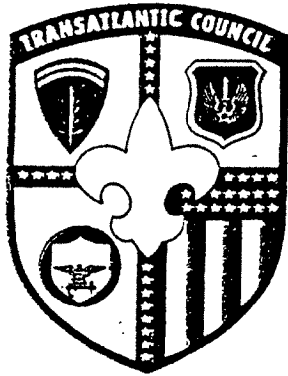

Sergeant sentenced to 8 years in prison

RHEIN-MAIN AB, Germany — A 24-year old sergeant here was sentenced to eight years confinement, at hard labor Wednesday for sodomy, indecent liberties and assault involving girls under the age of 16, a base spokesman said Friday.

A general court-martial board deliberated for six hours before convicting Sgt. Earl W. Cox Jr. of the 435th Combat Support Group.

Cox was also reduced to grade E-1 and dishonorably discharged and was ordered to forfeit all pay and allowances.
