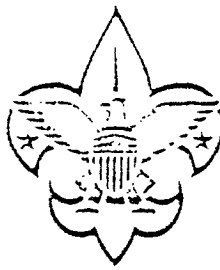

On Monday, October 24, 1988, at 1:47 p.m., [REDACTED] contacted our Council Service Center and informed us that her son, [REDACTED] admitted in a counseling session on or around September 27, 1988, that he had been sexually abused by EARL VICK while a member of Troop 88, sponsored by the VFW in Salina, Kansas. The alleged abuse took place while [REDACTED] and her son lived in Kansas. They moved to Casper, Wyoming in December 1987.

[REDACTED] has notified the Natrona County Sheriff's Department and also [REDACTED] and other parents in Troop 88. The Natrona County Sheriff has informed the Salina Police Department. Deputy, TODD CONDELARIO, of the Natrona County Sheriff's Department took the report.

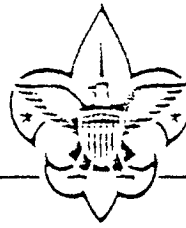


Dear Mr. Vick:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed-by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

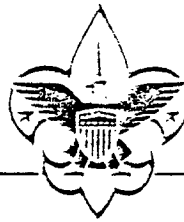
