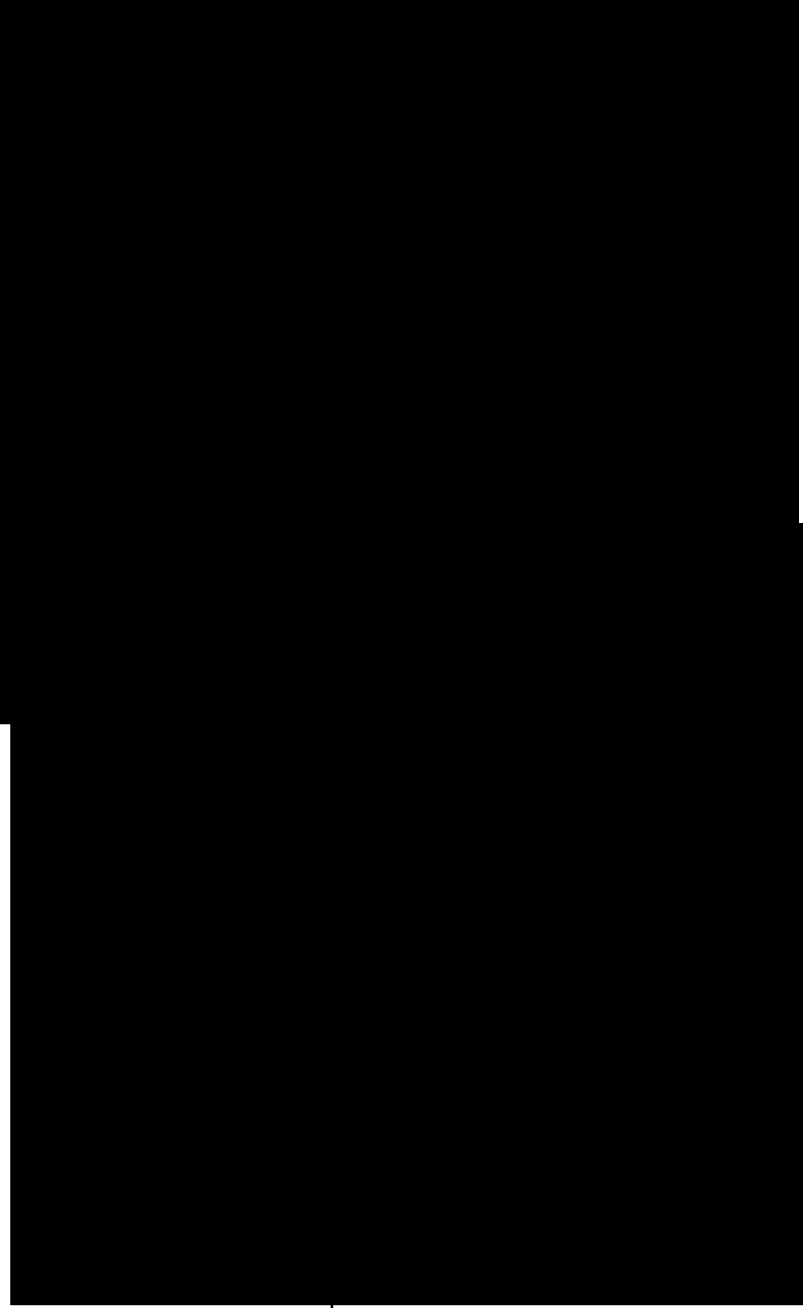
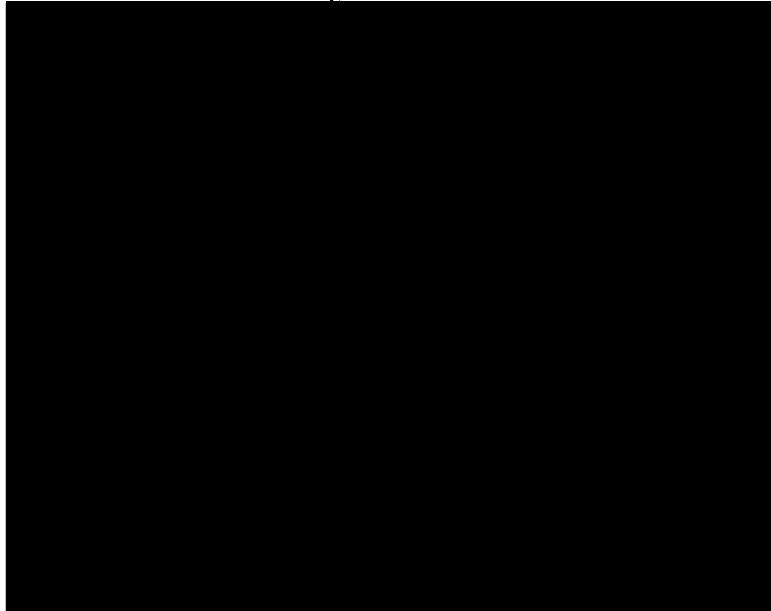

Druxman pleads guilty.

Ed Druxman, 69, of Colville, plead guilty last Friday in Stevens County Superior Court to indecent liberties, one count of rape of a child in the third degree, and one count of child molestation in the third degree.

Druxman had originally been charged with two counts of indecent liberties, and three counts of child rape in the third degree. The incidents involved male juveniles.

A pre-sentence investigation was ordered by Judge Larry Kristianson. A Nov. 15 sentencing was also set by the court.

Martin Rollins, assistant prosecutor, during the plea, recommended to the court that Druxman be sentenced to 21 to 27 months for indecent liberties, and four to 12 months for rape, and four to 12 months for child molestation.
