At approximately 11:15 AM on March 20, 1989 I received a call from a lady, who identified herself as a counselor at a grade school in Akron. The following was related to me: She said Art Oborn had been abusing his grandson, about 3 years ago. When she found out he was a Scout Leader, she wanted to inform our office. She thought he was an employee of the council. At this time I then explained the difference between a volunteer leader, and a professional staffer. She refused to identify herself and said the phone call should be good enough. I proceeded to explain that we needed written documentation on what she new about Art Oborn, she refused, and our conversation ended.

About two minutes later she called back and gave me her name, Jan Pisanelli, a counselor at Sieberling School (Market). She then proceeded to tell me Art also, abused his own son. I told her I would pass this information on to the Council Executive.

At 2:15 PM I called back, asking her for a written letter on the above. She said if she gets a release form from mother, she would do it. I asked her the age of the she said he was in the third grade.


