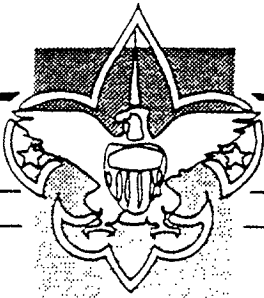



After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand the BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated.

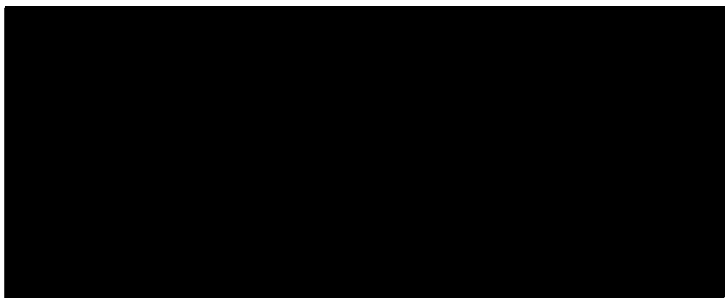
Independence police arrested six men in unrelated child sex abuse cases Wednesday.

Bobby R. Stone, 37, of 2342 Glenwood Ave., was arraigned Wednesday on one count of attempted forcible rape in connection with an alleged attack on a 15-year-old girl in April, Detective Ray Rast said. Stone posted a \$15,000 bond.

Edward L. Harvey, 40, of 708 N. Pearl St., was arraigned Wednesday on four counts of sodomy allegedly involving two girls, one 7 and one 8. Rast said. The offenses were alleged to have occurred between Jan. 1 and June 30, he said.

Harvey posted a \$40,000 bond.

Four other men - three from Independence and one from Excelsior Springs - were also arrested. Their names were withheld pending their arraignments later today.
