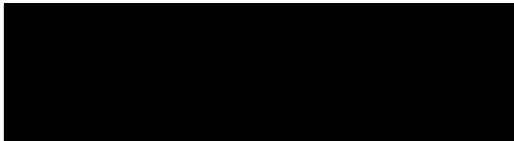

Meeting with Parents and Boys of Troop 814

On Saturday, December 5, 1987, a group of parents and boys of Troop 814 came to talk with the Scout Executive about a problem in the troop.

They explained that more than a year ago, the Scoutmaster at that time, Eladio Feliciano, was sexually molesting the Scouts, especially the new ones. He took naked pictures of himself and the boys during some troop camping activities. He has used some of the boys sexually and he utilized one of the boys to masturbate him.

Another boy reported that in one camping trip, he asked the Scoutmaster to allow his younger brother to pitch his tent near his, but the Scoutmaster didn't do it. The next day, the younger brother told the older brother that the Scoutmaster slept in his tent.

About two years ago, one of the Scouts was asked to undress by the Scoutmaster.

The Council Scout Executive explained to the parents about the Scouting rules and the procedures of the Boy Scouts of America in these cases.

One of the parents mentioned that the Scoutmaster used one of the boys as a woman (wife). This Scoutmaster has had problems at camp before.
