We will place him on the Confidential Files, so that we may make certain he does not get registered in some other council.

Mr. Horton has moved away from Dillon, Co., perhaps to Denver. As is often the case, he was a bit of a loner, somewhat secretive, and did not permit very many people to get well acquainted with him.

He moves around, and to the best of my knowledge was not convicted of any offense in Dillon or that area. Mr. Horton seems to have problems relating to people, and the social services department of Summit County suspected he was involved in several inappropriate acts, including pedifilia. The Scout leaders of that area were very suspicious of him. As I said, he moved out of town quickly, and we're not sure to where.
