In early October, I received a call from Barry Jackson, Cubmaster of Pack 310, regarding a Tiger Cub Adult (Dean Clutter) who had a reputation around his work place of being "one who plays with kids." I told Barry to keep his eyes and ears open as we had nothing but a reputation here.

On November 5, 1991, Barry Jackson called me at the Battle Creek office to explain that his Tiger Organizer had received an annonymus call detailing a child molestation in which Dean Clutter had been the perpetrator. I immediately called Cora Angell (the T.O.) to confirm this information. She gave me details of the phone call. She is willing to discuss the call with the Scout Executive.

I then called Mr. Dan Dowling, Assistant County Prosecutor, Calhoun Co. I asked for any information he could give me regarding Mr. Clutter.

On November 6, 1991 Mr. Dowling informed me that Mr. Clutter had a history of indecent exposure. Three charges had been levied against Mr. Clutter. Two guilty pleas were entered, and one charge was dismissed. This was in November of 1978. The complaints were handled by the Battle Creek City Police.

This matter was discussed with Mr Freund on November 6, 1991.

You should understand that B.S.A. membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to deny registration whenever there is a concern that an individual may not meet the high standards of membership which the B.S.A. seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

APPLICANT PROCEDURE FOR REQUESTING REVIEW
OF DECISION DENYING REGISTRATION

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to: East Central Region, 230 W. Diehl Rd., P. O. Box 3085, Naperville, IL 60566-7085. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
2. Upon receipt of the written request, a committee will be appointed to review the situation.
3. If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by no more than two other individuals, if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.
