

Dear Paul;

I come to you with another indefinite situation but I feel that it is my duty to advise you. Presently we have a man who has been most recently registered as Scoutmaster of Troop 350 by the name of Jorge Emilio Augilar Gomez. He has been extremely active in organizing a scout troop and is presently helping to organize an Explorer Post. He has done a pretty fair job of it. Just ten days ago I received a call from the County Health Department from the physician in charge who is a friend of mine. Dr. [redacted] advised me that Mr. Gomez is a transvestite and has definite homosexual tendencies. I asked on what basis and he said that was confidential and refused to divulge them to me since he said he was violating a patient-doctor conference as it was. At this date there have been no incidents involving Gomez, to our knowledge. Gomez is leaving this area for the Los Angeles area on the first of January 1975. We have not spoken to Gomez about this situation since he is leaving and should I be confronted with a charge to back up my statement I would have to back down and say I could not do it. For the record Mr. Gomez was born April 23, 1945 - height 6' 4" - dark brown or black hair - weight 200 lbs. His 1975 drivers license lists his previous place of residence as 230 East Chapman Avenue No # 22, Placentia, California 92670. He is extremely active and interested in First Aid and holds the classification of instructor in first aid and does a lot of work with the Red Cross. It is my understanding that he was born in Guatemala. His wife, Dia, plans to remain in this community and to remain active in the scouting program.

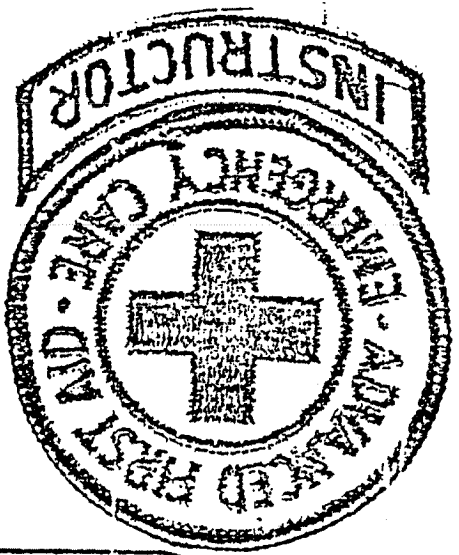
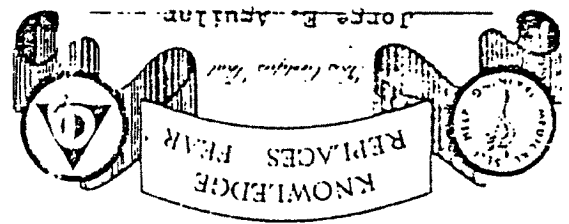

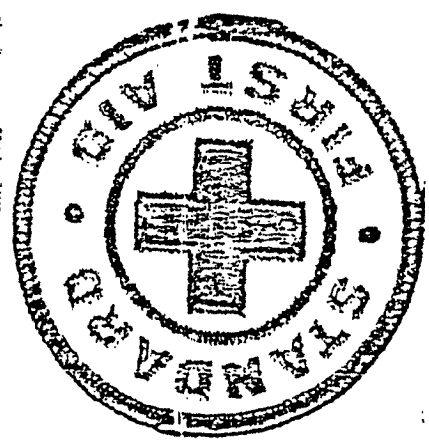
