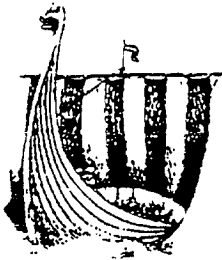

As you will recall, I received a call from Lynnette Nieman, Corrections Agent, with the Minnesota Department of Corrections, indicating that one Ernest John Folley who had been convicted of criminal sexual conduct in the 1st degree, would soon be released. He told Lynnette that he intended to become a volunteer in the Boy Scouts. She wanted to be sure that he would not be able to serve in this capacity. I assured her that we could take the necessary steps and asked her if she could send me any documentation. I have received that documentation, a copy of which is attached. Although, Mr. Folley is not currently registered with the Boy Scouts of America, I would ask that his name be placed on the ineligible volunteer file.

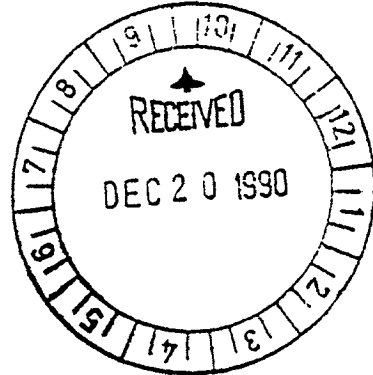

*The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense (s): The complainant states that the following facts establish PROBABLE CAUSE:*

Complainant states he is a Deputy Sheriff of Wright County, Minnesota, and makes this Complaint pursuant to his investigation and upon information from other law enforcement officers and professionals whom your complainant believes to be reliable.

Upon said information, complainant states that on the 5th day of November, 1987, he and Catherine Hogle, Wright County Human Services Department, met with one [REDACTED] age 13. Complainant states that at that time, the said [REDACTED] advised that from approximately May, 1985, to May, 1987, she resided with the defendant, Ernest John Folley, DOB 11/5/50, at [REDACTED] Wright County, Minnesota. Complainant states that from approximately October, 1985, through May, 1987, the defendant on numerous occasions had engaged in digital penetration and intercourse with the said [REDACTED].

CHARGE: COUNT I: CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE

In violation of Section: M.S. 609.342, Subd. 1(a)

Maximum Sentence: 20 years, \$35,000 or both

In that one Ernest John Folley did wrongfully, unlawfully and feloniously engage in sexual penetration with another person, to-wit: one [redacted] at a time when the said [redacted] was less than 13 years of age and the defendant was more than 36 months older than the said [redacted].

CHARGE: COUNT II: CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE

In violation of Section: M.S. 609.342, Subd. 1(b)

Maximum Sentence: 20 years, \$35,000 or both

In that one Ernest John Folley did wrongfully, unlawfully and feloniously engage in sexual penetration with another person, to-wit: one [redacted], at a time when the said [redacted] was at least 13 but less than 16 years of age and the defendant was more than 48 months older than the said [redacted] and in a position of authority over the said [redacted] and did use this authority to cause the said [redacted] to submit.

CHARGE: COUNT III: CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE

In violation of Section: M.S. 609.342, Subd. 1(h)(v)

Maximum Sentence: 20 years, \$35,000 or both

In that one Ernest John Folley did wrongfully, unlawfully and feloniously engage in sexual penetration with another person, one [redacted], at a time when the defendant had a significant relationship to the said [redacted], the said [redacted] was less than 16 years of age at the time of the said sexual penetration and the sexual abuse involved multiple acts committed over an extended period of time.

THEREFORE, Complainant requests that said Defendant, subject to bail or conditions of release be:  
(1) arrested or that other lawful steps be taken to obtain defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings;

and that said Defendant otherwise be dealt with according to law.
