Dear Chief Dolan:

I am following up on our conversation this morning related to Camp Onway. As I mentioned, my information was obtained from my interview with camper [REDACTED] on July 30, 1987.

[REDACTED] and 3 minor staff members were involved in drinking alcoholic beverages at camp in early July. The Camp Director's investigation discovered they were given the alcoholic beverages by adult staff member Ernest M. Darby (DOB 3/29/54) of [REDACTED], Andover, MA. Mr. Darby's camp employment was terminated on July 29 due to his involvement in the drinking incidents.

However, [REDACTED] also told me that on Thursday night, July 16 after drinking wine coolers with Mr. Darby and another staff member that he had a problem in his tent. I was told that upon returning to his tent at approximately 11:30 PM with Mr. Darby that he fell asleep for about 10 minutes. When [REDACTED] awoke, he had his pants down to his knees and Darby was handling his penis. [REDACTED] said he was shocked and when Darby asked if he should leave, [REDACTED] said yes. Sean said Darby apologized on Friday morning and stated "[REDACTED], I didn't mean for anything to happen."

On Thursday, July 30, 1987 Council President Larry Larsen and I met with Ernest Darby and presented him with a letter which stated the Boy Scouts of America were rescinding his membership with the BSA. No charges were made at this meeting.

Later that evening of July 30, 1987, I met with [REDACTED] parents for 45 minutes and shared the details of my meeting with [REDACTED]. I also told them North Essex Council would do whatever we could to support them should they decide to take this matter up with police officials. I was told on Friday, July 31 by [REDACTED], [REDACTED] father, that they wanted to drop this matter all together. They felt [REDACTED] was handling the situation fine and that justice was being served by Mr. Darby having to give up Scouting all together.

I also had a follow-up conversation with [REDACTED], [REDACTED] mother on August 3, 1987 to see how [REDACTED] was doing. [REDACTED] felt [REDACTED] was handling the situation fine and she reiterated that they wanted to put this situation behind them.

Again, I am notifying you of information I gathered in the process of this drinking investigation should you deem it necessary to investigate these matters further.

We received a phone call from you last July in which you indicated that an employee, during summer camp, had molested another staff member. There were also indications of alcohol being used and given to underage staff members.

We have written to you on a couple of different occasions since that time and have received no further word related to these incidents. We really need more information if we are to maintain a file which will lead to refusal of future registration attempts.

I am again enclosing a Confidential Record Sheet which I would like to have completed so we may identify Mr. Darby. This is most important so that we have a complete file for identification purposes should he move to another location.

If you have any statements from individuals or other material which would help to substantiate our refusal, please do not hesitate to send them. If any charges were lodged against Mr. Darby, we would also like to know of this.

THE FACTS:

Ernest Darby, 33, of [REDACTED], Andover, Mass. 01810, has been dismissed from his paid summer camp staff position as business manager on grounds that he provided alcohol to one or more young staff members. He was fired on July 29. Darby, a restaurant manager by profession, has also been registered as an assistant Scoutmaster of Troop 79, Andover, chartered to St. Robert's Catholic Church. It is the council's largest troop.

According to Harrop's information there actually were a number of drinking incidents, although the firing involved one such incident during which Darby is alleged to have provided wine coolers to two 16-year-old staff members off the camp property.

Darby is alleged, then, to have gone into a tent with one of the two 16-year-olds who claims he awoke to find Darby fondling him. The youth ordered him out of the tent and a confrontation followed the next day between the two. Word of the allegations then spread among the young camp staff. The BSA HAS MADE NO MORALS ALLEGATIONS IN THE MATTER, HOWEVER.

The parents of the youth involved in the tent incident have been notified.

ACTION OR RECOMMENDATIONS:

Harrop is taking action to see that Darby no longer remains active as a volunteer. He does not anticipate any criminal charges and believes the matter will be settled quietly. While there has been an apparent pattern of drinking among minors associated with Darby, the morals incident appears to have been an isolated one.
