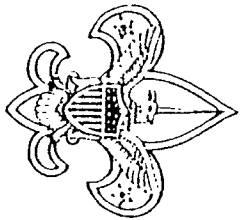

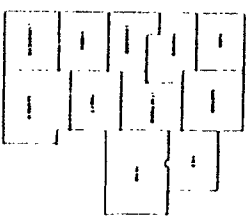

We received information from the St. Mississippi Council in Janesville, WI, which indicated that Mr. Jensen had been arrested and convicted of sexual contact with a minor on two different occasions in 1963 and 1972. This caused us to place his name on our confidential file, so that he could not be registered in the future.

According to our files, he may have been registered in your council in 1969-50550 until April of 1989. Our records indicate he was registered with ID #011530.

We would like to know if you had any information concerning this matter, or whether you had any problem with Mr. Jensen while he was registered in your council. This information will help to complete the file and make certain that he cannot register in the future.

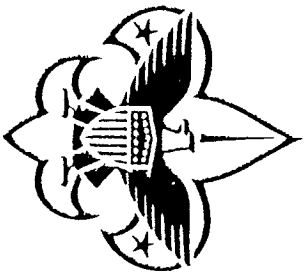

I received an anonymous phone call on August 28, 1989 from a lady expressing concern over a new Scoutmaster, Mr. Eugene H. Jensen, Sr. The caller made accusations that Mr. Jensen had been arrested and convicted of child sexual abuse and felt that I should check this out.

I made an inquiry through the Janesville Police Department and found that Mr. Jensen, with the Social Security Number of [REDACTED] was indeed arrested and convicted of two charges stemming from sexual contact with a minor in 1963 and 1972.

As a result, our office has returned Mr. Jensen's registration fee with the attached letter. I would also recommend that a check be done on Mr. Jensen's past B.S.A. registrations and that these Councils be made aware of his past criminal record.

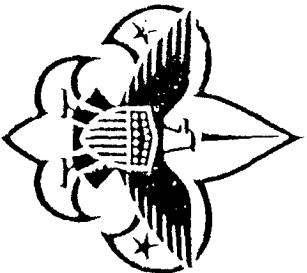

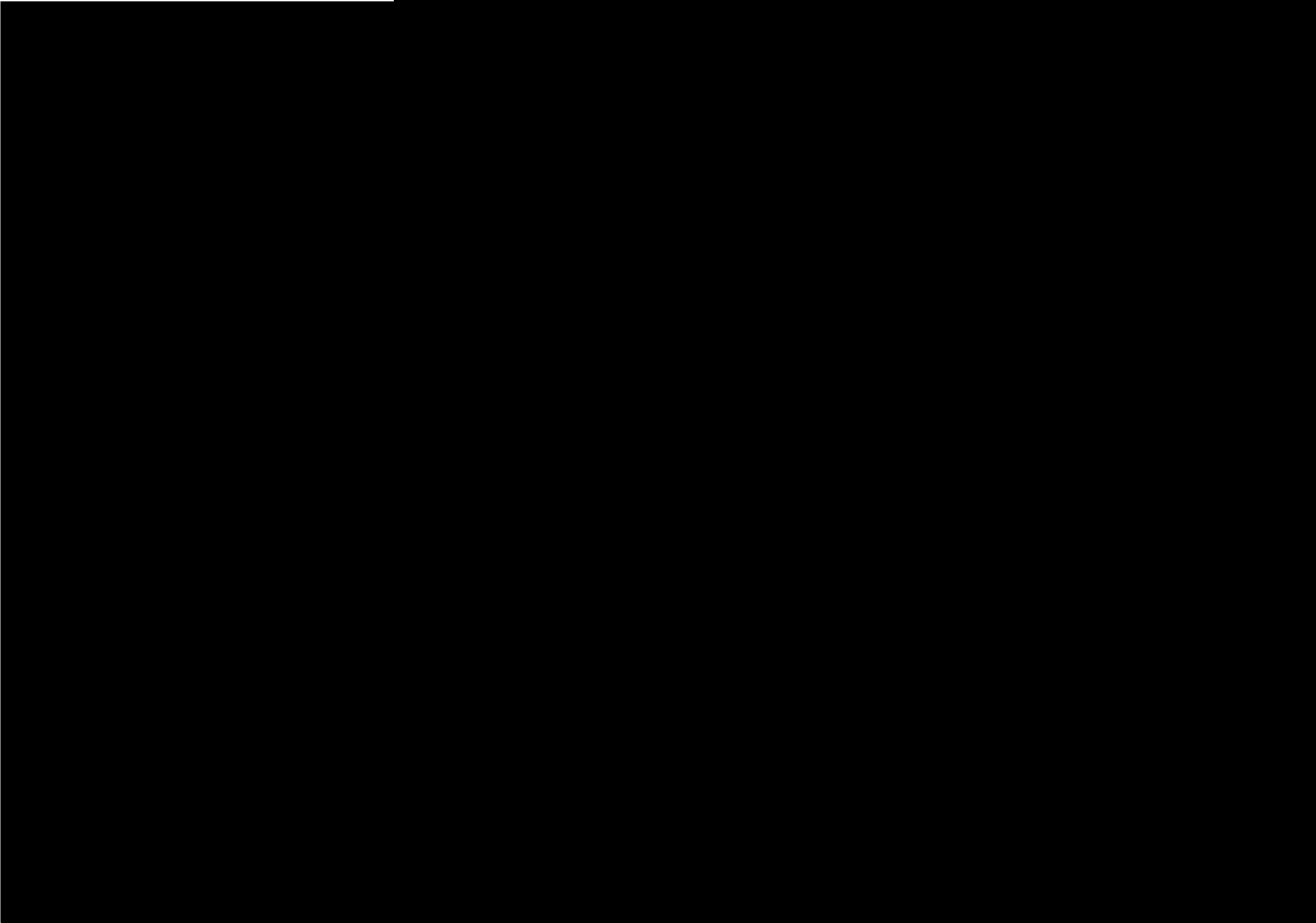
