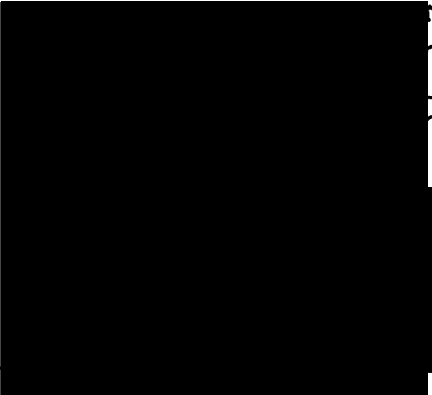

Man gets 12 years in sex abuse of boy

A former Westmont emergency medical technician who pleaded guilty to aggravated criminal sexual abuse of an 11-year-old Du Page boy was sentenced this week to 12 years in prison.

Farrell Theis, 26, of Westmont, who was employed for several years as a medical technician with the Westmont Fire Department, was sentenced by Circuit Judge Brian Telander after he heard testimony by several other youths who claimed to have been sexually abused by Theis.

Theis is also a former assistant Scoutmaster in the village. According to testimony presented by Assistant States Atty. Leann Schied, he would lure youngsters into the Fire Department ambulance by telling them that they would get to see medical equipment, see how a medical technician treats injured people or else take a physical to join the Boy Scouts.
