Purpose of Visit:

Consultation with Council President Richard Van Sistine, Immediate Past President George Banta, III (also Past President Neenan Menasha United Fund) regarding employment of former Valley Council Executive Dwight Donelson, as Executive Secretary of United Fund.

Conditions Found and Action Taken:

I met with President Van Sistine and determined plan of action. We talked with Mrs. [redacted] with whom we consulted at the time of Donelson's resignation as Scout Executive of Valley Council in September 1966. Learned that Donelson had resigned as Secretary of United Fund two weeks after his appointment. Had been on the job only two days. I met with George Banta and advised him of the real reason for Donelson's resignation. Then in consultation with Banta, Van Sistine and Council Commissioner Richard Loescher we agreed that I should tell Donelson to get out of town. I met with Donelson and told him that if he did not get out of town Mrs. [redacted] (Mr. [redacted] died in January 1966) would take the matter up with the District Attorney and Juvenile Court. Donelson asked me if in case he did not get out of town and he became involved in Juvenile Court proceedings would the Regional Office and National Office assist him in his defense. I told him absolutely not. He then asked me how much time he had to get out of town and I told him that no time limit had been established but he should get out as soon as possible. I shall be back in the Valley Council in the latter part of September and will follow up on this situation.

Note: Council Commissioner Richard Loescher advised me and I in turn advised Donelson that there is a possibility of him obtaining employment with a paper manufacturing trade's association national office in New York City.

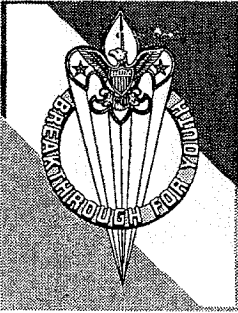

Dick Newcomb suggested that I write directly to you with this special report on F. Dwight Donelson and his recent separation from Boy Scouts of America. Boyd, of Registration has asked for a report on this and I assume that you will see that this information is passed on to him at your earliest convenience.


F. Dwight Donelson was asked to resign by the Council President, Richard Van Sistine. The reason--moral charges. Donelson is a pervert. I interviewed camp staff members, camp director, camp ranger. Finally secured a signed statement from one boy whom I interviewed in the presence of his parents. Two other boys who were involved were not interviewed. Armed with this statement, I met with the President and Commissioner, Richard Loescher.

The President called Donelson in to meet with the three of us. He asked Donelson to resign and told him why. We didn't have to use the circumstantial evidence assembled from the interviews nor the signed statement. Donelson resigned immediately without discussion or argument.

The Camp Director, Keith Fawcett, instigated my investigation. He called me while I was attending National Staff Conference at Schiff, date 9/7/66. He did not call me previously because he didn't know just what to do. He said the situation finally bothered him so much that he felt he had to call me for advice. I consulted with Otto Nintz while at Schiff for advice on investigating the charges.

I trust this adequately clarifies the situation.

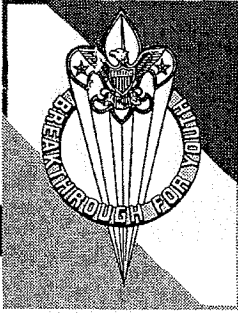

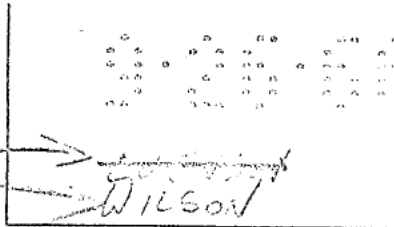

Donelson has told Luebben not to come in the office any more. Luebben will advise me next week whether or not he wants to be considered for another job in Scouting.

I met with Donelson and DE Wright and Nebel regarding membership. I pointed out steps to be taken this fall regarding new units and additional enrollments--Donelson and they promise a good gain by end of year--several new units being organized.

I drove to Marshfield to interview Keith Fawcett, summer camp director regarding irregular practices in connection with camp operations on Donelson's part. I then drove back to Appleton and met with Council Commissioner Richard Loescher--could not see council president who was out of town. I then interviewed Mr. and Mrs. [redacted] and son [redacted] who had resigned from camp staff after being on job two weeks. Still have more investigating and checking on complaints and rumors to do.

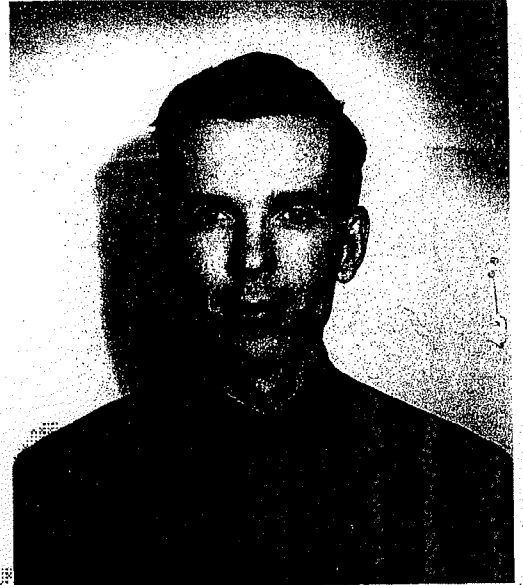

Dear Frank:

Brandy's October 24 report on Council 635 concerning Scout Executive, F. Dwight Donelson, is in my hands as I write this letter to you. At the end of the report, under recommendations made, not only does he make the statement that Donelson should not be re-employed but that he should be placed on C.I.L.. We assume he means the confidential file, and this is the purpose of writing.

Why should Mr. Donelson be placed on the confidential file? There are no reasons in Brandy's report to substantiate this action. Would either you or Brandy please give us more specific information? It is my understanding that Mr. Donelson is approximately 40 years of age and a bachelor. Further, Brandy makes the statement in his main paragraph that "Donelson has had personnel problems with summer camp staff members including the Camp Director". Are there any moral charges involved here?
