**Scout volunteer charged
with sexually assaulting
four boys, aged 12 to 14**

A volunteer counselor with the Boy Scouts has been charged with 11 counts of first- and second-degree criminal sexual conduct with four Boy Scouts.

Floyd F. Pietz, 47, of Apple Valley was charged Tuesday in Dakota County Court. Judge Jack Mitchell set bail at \$25,000 and Pietz was confined in the county jail. He is to appear Monday in district court.

The complaint alleges that Pietz sexually assaulted the boys, aged 12 to 14, between December 1980 and Oct. 9 of this year at his home at Fort Snelling State Park in Mendota Heights and Crystal Lake in Burnsville.

The investigation by Dakota County sheriff's deputies and Lakeville police followed a complaint against Pietz by a Boy Scout official and Assistant County Attorney Thomas B. Bink.

SUBJECT: Concern for a local problem similar to the one that surfaced last week in the Rochester Scout Council.

No doubt you have become aware of the attention recently given a Scouter from the Rochester Council through the media. Unfortunately, a similar situation has surfaced here in our council. The individual was arrested this past Saturday and will be formally charged in Dakota County by noon, Tuesday, October 26.

As you might suspect, circumstances of this nature are always very difficult. However, individuals with this kind of problem do come to our attention from time to time. A plan to aid the troops as well as their boys and families is now in place.

We suspect that as soon as formal charges are filed (noon tomorrow) this data will become public information and, therefore, be covered by the news media. Rather than have you hear this from another source, we thought it appropriate to inform you via this memo.

Just so you know, we have talked with the staff of our council and suggested they refer all inquiries from news personnel to yours truly, either here at one office or at home (435-2025). Also a formal letter has been prepared to inform the person being charged that his membership in the BSA has been suspended.

If by chance you feel you would like to communicate further on this-matter, don't hesitate to call me.

Scout counselor is charged for sex acts

A 47-year-old Boy Scout volunteer counselor from Apple Val-
ley has been charged in Dakota County Court with 11 counts of
first-degree and second-degree criminal sexual conduct against
four Boy Scouts.

Floyd Fenten Pietz, 47, of 148 Garden View Drive, was
charged in court at Hastings on Tuesday.

Judge Jack Mitchell set bail at \$25,000, and Pietz was con-
fined in the county jail. Pietz is scheduled to appear in District
Court at 8:30 a.m. Monday.

According to the complaint, Pietz allegedly sexually assault-
ed the boys, ages 12 to 14, between December 1980 and Oct. 9 of
this year.

Assistant County Attorney Thomas Bibus said two alleged as-
saults occurred at the Pietz home and several other alleged
assaults occurred during camping and fishing trips to Fort
Snelling State Park in Mendota Heights and at Crystal Lake in
Burnsville.

The complaint alleged that Pietz performed sexual acts with
the boys. The investigation by Dakota County sheriff's deputies
and Lakeville police followed a complaint against Pietz by a
Boy Scout official, Bibus said.

Pietz has been associated with the Indianhead Council, Boy
Scouts of America, a council official said.
