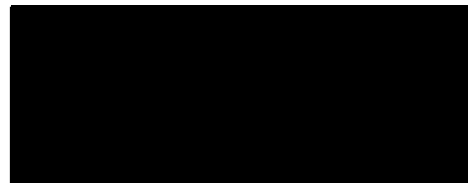

I, [redacted], was molested sexually by Floyd Smitty at the district fall camporee. I recall this to have been during the fall of 1974. The camporee was held on private property located very near the Jeremiah Morrow Bridge on I-71.

I was a member of Troop 122 (Maineville, Ohio Volunteer Fire Dept.). Floyd Smitty was the assistant scoutmaster of the troop.

During the actual molestation Floyd attempted both oral and anal sodomy, and demanded that the incident be kept absolutely secret.

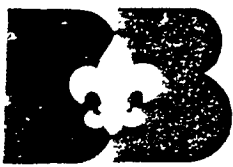

Dear Mr. Smitty:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.
