The prisoner, the above named Frank Ray Anderson defendant, being personally present in open court, and with his attorney Michael Miller, and having been legally presented by information by the District Attorney of said county for the crime of LEWD MOLESTATION

and said defendant having been arraigned entered herein his plea of guilty to the crime of Lewd Molestation, as charged in said information and being asked by the court if he had any legal cause to show why judgment and sentence should not be pronounced against him, and he giving no good reason in bar thereof:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the court that the said Frank Ray Anderson be confined in the State Assessment & Reception Center at Lexington in the State of Oklahoma, for the term of Fifteen (15) \* years for said crime by him committed. Said term of imprisonment to begin at and from the day of his incarceration therein, and the said defendant pay the costs of this prosecution for which execution is awarded. \* Defendant to serve ten (10) years with the Department of Corrections, five years to be suspended. Defendant not to associate with children under the age of eighteen years of age at any time.

Said last named copy to be returned to the clerk of said court with the proceedings of said sheriff thereunder endorsed thereon.

## in molestation

A former Grandfield High School custodian pleaded guilty Tuesday to molesting a teen-age boy in the school's cafeteria almost a year ago.

Sentencing for Frank Ray Anderson, 57, Grandfield, was continued until March 1, according to a secretary in the Tillman County District Attorney's office.

Anderson previously pleaded guilty to the charge back in July 1990, but then withdrew the plea before formal sentencing, the secretary said. She would not comment on whether prosecutors recommended a sentence and Assistant District Attorney Kelly Roberts refused to comment on the case.

The Tillman County Court Clerk's Office also refused to provide information from the court record over the telephone.

Anderson was accused of sodomizing a 16-year-old boy in the school kitchen on Feb. 26, 1990. The school superintendent, Darrell Britz, walked in while the molestation was occurring, according to a police report. Anderson immediately resigned from his post at the school as chief custodian.

Anderson was registered with Pack 132. Their recharter was not updated; therefore, Anderson was not reregistered in October of 1989. He currently is not registered with the B.S.A. and will never be registered again.

So far there have been no newspaper articles written on this matter. There are yet no court records available. I will make every effort to keep you posted on future information pertaining to this case.
