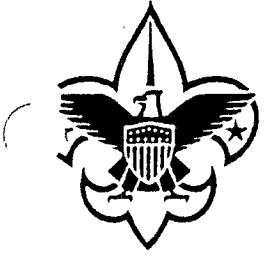



Re: Letter of Complaint - Frank Peot

Dear Mr. Chandler:

This is to advise you that by this letter we are giving notice to the scouts that in the years 1972 through 1977 a scout leader by the name of Frank Peot sexually abused [REDACTED]. The first instance of sexual abuse occurred on a scout outing in the area of Sun Prairie under the care of then scout leader Frank Peot. This is being brought to your attention on behalf of concern for the continued victimization of minors by this individual through use of the power and position of authority conferred on scout leaders such as Mr. Peot. Please consider this notice of complaint and advise us what the status, if any, presently is with the scout organization. [REDACTED] date of birth is [REDACTED] [REDACTED] is available to provide additional information if you need it in order to investigate and take the appropriate action within your organization in connection with this letter of complaint.
