In my job as Post Advisor three members of the Post, [REDACTED], [REDACTED] and [REDACTED] have related to me certain statements that I believe to be true, but which I cannot personally attest to.

These three boys have accused Frank Focaccio of Immoral acts of Sodomy and I feel it is my responsibility to relate these accusations to the District Executive. This I did to Mr. Leo Dugan on Tuesday March 1, 1966.

Mr. Dugan advised me to come and repeat them to Don Sweeney. This I did on Wednesday March 2, 1966.

Mr. Sweeney has advised me not to discuss this further with anyone and I agree to the wisdom of this advice and will not discuss it further with anyone.

I request Mr. Sweeney to take whatever steps the Boy Scouts of America, Philadelphia Council deem necessary to insure that the moral life of the boys and the Integrity of the Program are not damaged.

I willingly agree to signing this statement.
