After careful review, the National Council has decided that your registration with the Boy Scouts of America should not be allowed. We are, therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to decline any registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reason for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to us, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted. The procedures for a review of this decision are attached.
