You should understand that B.S.A. membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to deny registration whenever there is a concern that an individual may not measure up to the high standards of membership the B.S.A. seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a B.S.A. member should be granted. The procedures for review are attached.

Thanks for the information concerning the above named individual. I feel this is most helpful to us in starting a Confidential File. The information you received certainly would warrant placing Mr. Willie on our Confidential File, so the registration could be refused in the future. He must request a review and prove that he is not guilty before we again register him.

I am enclosing a Confidential Record Sheet, which I would like to have completed, so we may identify him should he move somewhere else and attempt registration. We would like a paper with Mr. Willie's signature, as this aids in the identification process.

I believe you should send Mr. Willie a letter indicating that he is no longer eligible to be registered with the Boy Scouts of America. This could be indicated rather than using the first sentence of the recommended letter. He would then have the option of a review if he requested this.

Once we receive the information you have indicated we will have a complete file.

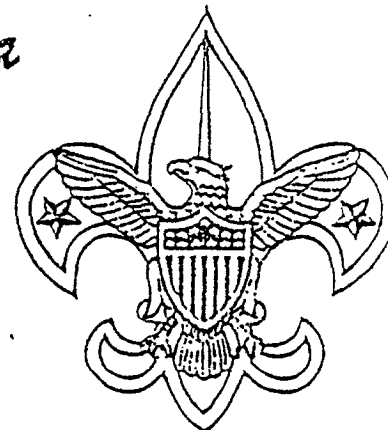

"He would show them pornographic photos." Mr Shael said after reviewing the youth protection material produced by national ~~the~~ Mr Willie fits all the descriptions of a pedophile.

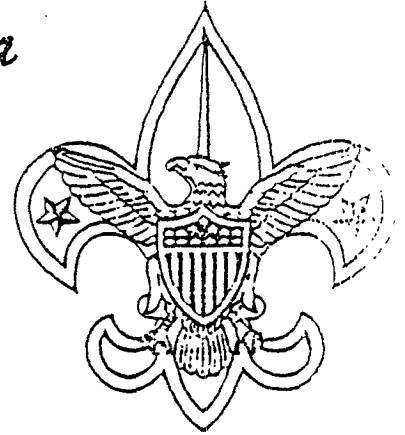
