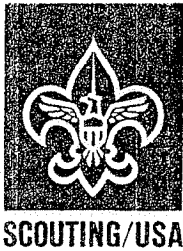

The information on Fredric A. Tietz was called into the Council Office by a volunteer Scouter who is a private detective and has access to police files in Baltimore, Maryland. It was confirmed by another private detective, also a volunteer Scouter, who has access to the same files.

Fredric A. Tietz was arrested after being caught in a homosexual act with an 11 year old boy on July 5, 1966 at Colonial Beach, Maryland. He posted \$250.00 collateral and forfeited the collateral.

The suggestion that this man be placed in the confidential file is submitted for your consideration.


